12. Legal Description of Facility:

The legal description of this facility is contained in Figure 2 of the Report of Disposal Site Information/ Joint Technical Document dated May 2016.

13. Findings:

- a. This permit is consistent with the Inyo County Integrated Waste Management Plan, which was approved by the CalRecycle. The location of the facility is identified in the Countywide Siting Element, pursuant to Public Resources Code (PRC), Section 50001(a).
- b. This permit is consistent with the standards adopted by the CalRecycle, pursuant to PRC 44010.
- c. The design and operation of the facility is consistent with the State Minimum Standards for Solid Waste Handling and Disposal as determined by the enforcement agency, pursuant to PRC 44009.
- d. The Bishop Volunteer Fire Department has determined that the facility is in conformance with applicable fire standards, pursuant to PRC, 44151.

A Mitigated Negative Declaration (MND) was filed with the State Clearinghouse (SCH #1999041076) and adopted by the Inyo County Dept. of Environmental Health on 5/19/1999. The MND describes and supports the design and operation, which will be authorized by the issuance of this permit. A Notice of Determination was filed with the State Clearinghouse on 09/28/1999. An addendum to the 1999 MND (allowable per CEQA guidelines Section 15164) was prepared in October of 2012 reflecting the minor technical changes proposed in this permit revision.

14. Prohibitions:

The permittee is prohibited from accepting the following wastes:

Hazardous, radioactive, medical (as defined in Chapter 6.1, Division 20 of the Health and Safety Code), liquid, designated, or other wastes requiring special treatment or handling, except as identified in the Report of Facility Information Joint Technical Document and approved amendments thereto and as approved by the enforcement agency.

16. Self-Monitoring:

The owner/operator shall submit the results of all quarterly and annual self monitoring programs to the Enforcement Agency within 30 days of the end of the reporting period (*for example, 1st quarter = January – March, the report is due by April 30, etc... Information required on an annual basis shall be submitted with the 4th quarter monitoring report, unless otherwise stated*). Information required on a monthly basis shall be available for review by the Enforcement Agency within 7 days of month’s end.

17. Enforcement Agency (EA) Conditions:

- a. The operator shall comply with all State Minimum Standards for solid waste handling and disposal as specified in Title 27, California Code of Regulations (CCR).
- b. The operator shall maintain a log of special/unusual occurrences. This log shall include, but is not limited to fires, explosions, the discharge and disposition of hazardous or unpermitted wastes, and significant injuries, accidents or property damage. Each log entry shall be accompanied by a summary of any actions taken by the operator to mitigate the occurrence. The log shall be available to site personnel and the EA at all times.
- c. Additional information concerning the design and operation of the facility shall be furnished upon request and within the time frame specified by the LEA.
- d. The maximum permitted daily tonnage for this facility is 160 tons per day and shall not receive more than this amount without a revision of this permit.
- e. This permit is subject to review by the EA and may be temporarily suspended or revoked at any time by the EA for sufficient cause, in accordance with Division 30 of the Public Resource Code, Part 4, Chapter 4, Article 2, Sections 44305 et seq. and associated regulations.
- f. The LEA reserves the right to suspend or modify waste receiving and handling operations when deemed necessary due to an emergency, a potential health hazard, or the creation of a public nuisance.
- g. Any change that would cause the design or operation of the facility not to conform to the terms and conditions of this permit is prohibited. Such a change may be considered a significant change, requiring a permit revision. In no case shall the operator implement any change without first submitting a written notice of the proposed change, in the form of an RFI amendment, to the LEA at least 180 days in advance of the change.
- h. A copy of this permit shall be maintained at the facility.
- i. The operator shall provide adequate on-site and off-site litter control.
- j. The operator shall compile daily tonnage received and make available to the LEA monthly.
- k. All tires shall be accepted, sorted, stored, and disposed of according to CCR Title 14.
- l. Storage of green material and mulch/chips must be done in accordance with CCR Title 14 and as described in the RDSI/JTD.
- m. Alternative daily cover can be used as approved in current RDSI/JTD.
- n. The amount of stockpiled concrete, tracked with the daily logs, shall not exceed 10,000 tons.
- o. The land farm for petroleum contaminated soils shall be operated as described in the RDSI/JTD and per CCR Title 14.
- p. The operator shall comply with all mitigation measures specified in any certified or adopted environmental documents that are within the authority of the LEA and are contained in a mitigation monitoring and reporting program, pursuant to Public Resources Code (PRC), Section 21081.6 and as described in the RDSI/JTD.
- q. Dead animals shall be completely covered as soon as possible and at a minimum at the end of the working day with 12 inches of soil.
- r. Ashes from household wood stoves or incinerators, and burn barrels shall be deposited away from the working face and watered on days when ashes are disposed.
