I. Joint Request For Continuance

On September 4, 2014, the parties filed a written Joint Request For Continuance Of Hearing Date (Continuance Request) in this matter in order to pursue settlement negotiations. Martha Perez signed the Continuance Request as counsel for CalRecycle. Stephen Krauss signed on behalf of Respondent Golden By-Products, Inc. The record in this matter reflects that Mr. Krauss is the contact for Respondent and signed Respondent's Notice of Defense.

The parties request that the hearing be continued to October 15, 16 and 17, 2014.

Good cause exists to continue the hearing based on the reasons stated in the joint request. The continuance is hereby granted, and the hearing that was scheduled for September 10, 11 and 12, 2014 is continued to the dates set forth below.

II. Waiver of 60-Day Time Line

Public Resources Code section 42851(b) provides for a hearing to be held within 60 days of the scheduling date. The Notice of Hearing in this matter was filed and served via mail and email by CalRecycle on July 25, 2014, and the 60-day time period ends on September 23, 2014. In their Continuance Request, CalRecycle and Respondent Golden By-Products, Inc. waived the 60-day time line for holding a hearing.


