**12. Legal Description of Facility:**

**13. Findings:**

- a. This permit is consistent with the standards adopted by the Department of Resources Recycling & Recovery (CalRecycle) as required by Title 14, California Code of Regulations (CCR), Division 7, Chapter 6.
- b. The design and operation of the facility is consistent with the Waste Tire Storage and Disposal Standards applicable to a minor waste tire facility, pursuant to PRC §42830 et. seq. and implementing regulations found in 14 CCR, Division 7, Chapter 3.
- c. The facility site is located in a General Industrial (IG) zone, and is consistent with the City of Long Beach's General Plan Land Use Element and zoning designation. The project involves negligible or no expansion beyond the existing permitted land use and; therefore, it is determined that the project is categorically exempt pursuant to 14 CCR, Section 15301-- Existing Facilities.
- d. This permit does not release the permittee from their responsibility under any other existing laws, ordinances, regulations, or statutes of other government agencies.

**15. Conditions:**

- a. The permittee shall store no more than a total of **4,999** waste tires on-site, at any given time. A waste tire includes a repairable tire, scrap tire, baled tire and altered waste tire, but does not include a tire derived product, crumb rubber (less than or equal to 1/4 inch in size), or a properly stored used tire. If the permittee proposes to store more than 4,999 tires, then the permittee must first acquire a Major Waste Tire Facility Permit.
- b. The design and operation of this facility shall comply with the applicable Waste Tire Storage and Disposal Standards contained in 14 CCR, Division 7, Chapter 3. The permittee shall also comply with the permitting requirements in 14 CCR, Division 7, Chapter 6.
- c. In the event of a fire or other emergency that may have potential significant off-site effects, the permittee shall notify CalRecycle within 24 hours.
- d. Upon presentation of proper credentials, the Local Enforcement Agency, CalRecycle staff, or other authorized agent of CalRecycle, shall be allowed to enter the permitted facility during normal operating hours to examine and copy books, papers, records, or memorandum, to take photographs of the tire storage area, and to conduct inspections and investigations pertaining to the facility. CalRecycle staff, designated contractors and representatives shall also have access to the facility to investigate, remediate, or stabilize the facility, if such activities are deemed necessary to protect the public health, safety and the environment.

## 15. Conditions: (continued)

- e. A copy of this permit shall be posted in a visible location at the facility.
- f. The permittee shall maintain copies of all comprehensive trip logs documenting tire movement in and out of the facility for a minimum of 3 years.
- g. The permittee shall maintain a copy of the Fire Authority approval at the facility. The permittee shall maintain a copy of the Emergency Response Plan at the facility. At the time of permit issuance, the permittee shall forward a copy of the Emergency Response Plan to the local fire authority. The Emergency Response Plan shall be revised as necessary to reflect any changes in the operations of the waste tire facility or requirements of the local fire authority. Such revisions to the operation plan or emergency response plan will not be effective until CalRecycle concurs with the revisions. All emergency phone numbers shall be updated immediately. The local fire authority and CalRecycle shall be notified of any changes to the plan within 30 days of implementing the revision.
- h. Other local permits or approvals referenced in this permit shall be maintained in force during the term of this permit. In the event the permittee intends to modify any permit or approval from another government program, including but not limited to Air Resources Board, State Water Control Board, or CalRecycle programs, during the term of this permit, the permittee shall notify CalRecycle in writing within at least 30 days prior to the change and include copies of any renewed or modified permits or approvals from these agencies. In the event any permit or approval from another government program is suspended or revoked, or expires during the term of this permit, the permittee shall notify CalRecycle in writing within 5 working days of the suspension, revocation or expiration, and include copies of the pertinent documents with the notification.
- i. The permittee shall notify CalRecycle in writing of each administrative change no later than seven (7) business days after the change is effective. Administrative changes shall include, but not be limited to changes to any information in the application that does not apply to the design, operation of the facility.
- j. If the owner or operator of this facility plans to sell, encumber, or transfer or convey the ownership or operation of the facility or land to a new owner or operator, or who plans to change their address, then the permittee shall notify CalRecycle 30 days prior to the date of the planned transaction. The new owner or operator shall submit information to CalRecycle as prescribed in 14 CCR, Division 7, Chapter 6, Section 18428.
- k. The permittee shall maintain a copy of the Waste Tire Facility Operation Plan (Operation Plan) at the facility. All site conditions, equipment, and precautions outlined in the Operation Plan shall remain in force. In no case shall the permittee implement any change of the permit conditions herein without first seeking approval from CalRecycle by submitting a written notice of the proposed change to the Enforcement Agency at least 90 days in advance of the change.
- l. This permit does not release the permittee from their responsibility under any other existing laws, ordinances, regulations, or statutes of other government agencies.
- m. The terms and conditions of this permit may change as a result of a revision of CalRecycle's statutes or regulations.
- n. The permittee must report to CalRecycle the receipt of 10 or more waste or used tires from unregistered haulers in a manner that is consistent with Title 14 CCR §18461.
- o. CalRecycle staff reserves the right to suspend or modify waste tire receiving and/or storage operations when deemed necessary due to an emergency, a potential health hazard or the creation of a public nuisance, to protect the public health and safety, protect and rehabilitate or enhance the environment, or to mitigate adverse environmental impacts.
- p. Violation of any term or condition of this permit or applicable Waste Tire Storage and Disposal Standards may result in enforcement action(s) which include but are not limited to the following: issuance of orders (clean up and abatement or cease and desist); penalties (civil, administrative, criminal); and permit revocation or suspension.
- q. The permittee shall only give, contract, or arrange with California registered used and waste tire haulers to transport waste tires or tire pieces (greater than 1/4") away from the facility, unless the hauler is exempt as specified in PRC §42954, or CalRecycle has granted written approval to the permittee or the hauler.

## 15. Conditions: (continued)

- r. This permit has been issued to the operator for the waste tire facility located at 2130 Technology Place, Long Beach, CA and is not transferable to any other location (PRC §42808).
- s. Prior to initiating closure of this facility, the permittee shall notify and obtain written approval from CalRecycle of the proposed final destination sites, where the tires are planned to be taken (14 CCR §18440 & 18441).
- t. Waste tires store indoors must be stored under conditions that meet or exceed those as published by the National Fire Protection Association. The permittee shall maintain a copy of the local fire authority approval(s) at the facility. Any change in, or any new, local fire authority requirements that affect the design or operation shall be reported to CalRecycle by the operator within 30 days after their effective date (14 CCR § 17356).
- u. Waste tires shall be arranged as approved by the local fire authority and as described on the plot plan on page 5 of this permit.
