NOTICE IS HEREBY GIVEN that an administrative hearing shall be held before the Department of Resources Recycling and Recovery (CalRecycle) at the dates, times, and locations listed below upon the charges made in the Statement of Issues for the Revocation of Minor Waste Tire Facility Permit and Administrative Complaint for Waste Tire Storage and Waste Tire Hauler Administrative Penalties that has been served upon you.

If you object to the place of hearing, you must notify the Hearing Officer through the Hearing Clerk within 10 days after this notice is served on you. Failure to notify the Hearing Officer within 10 days will deprive you of a change in the place of the hearing.

You may be present at the hearing. You have the right to be represented by an attorney at your own expense. You are not entitled to the appointment of an attorney to represent you at public expense. You are entitled to represent yourself without legal counsel. You may present any relevant evidence, and will be given a full opportunity to cross-examine all witnesses testifying against you. You are entitled to the issuance of subpoenas to compel the attendance of witnesses and the production of books, documents, or other things. Subpoena forms, and information about the use and service of subpoenas, can be obtained by contacting the attorney for CalRecycle or the Hearing Clerk, and may accessed online at the following address:

www.calrecycle.ca.gov/tires/enforcement/hearings.

Pursuant to Government Code section 11435.05 et seq., parties are entitled, upon request, to be provided with the assistance of an interpreter if they do not

1 proficiently speak or understand the English language. If you require the assistance of
2 an interpreter; timely notice of this fact should be given to CalRecycle so that
3 appropriate arrangements can be made. Please notify the Hearing Clerk of your need
4 for an interpreter at least 15 days before each date on which the services will be
5 needed.

7 Continuances are not favored. If you need a continuance, submit a written
8 request to the Hearing Clerk immediately. You must also provide a copy of the
9 request for a continuance to the CalRecycle attorney. Requests submitted less than
10 10 days before a hearing and requests not supported by good cause will be denied.




