12. Legal Description of Facility:

The legal description of this facility boundary is described and mapped in the Transfer Processing Report dated November 2014. The facility is located within Sutter County Assessors Parcel Nos. 54-083-023 and 54-083-014.

13. Findings:

- a. The location of the facility is identified in the Regional Waste Management Authority Siting Element, (Non disposal Facility Element), pursuant to Public Resources Code (PRC), Section 50001(a).
- b. This permit is consistent with the standards adopted by CalRecycle, pursuant to PRC 44010.
- c. The design and operation of the facility is consistent with the State Minimum Standards for Solid Waste Handling and Disposal as determined by the enforcement agency, pursuant to PRC 44009.
- d. A Mitigated Negative Declaration was filed with the State Clearinghouse (SCH #2014052082) and certified by the City of Yuba City Planning Commission on July 23, 2014 regarding Use Permit 12-01. The Mitigated Negative Declaration describes and supports the design and operation which will be authorized by the issuance of this permit. A Notice of Determination was filed with the State Clearinghouse on July 24, 2014.
- e. The operator will comply with all applicable federal, state, and local requirements and enactments, including mitigation and monitoring measures developed in accordance with any certified environmental documents filed pursuant to Public Resources Code (PRC) Section 21081.6 and administrative or enforcement orders of regulatory agencies with jurisdiction at this facility.

14. Prohibitions:

The permittee is prohibited from accepting the following wastes:

Hazardous, radioactive, medical (as defined in Chapter 6.1, Division 20 of the Health and Safety Code), liquid, designated, or other wastes requiring special treatment or handling, except as identified in the Transfer Processing Report and approved amendments thereto and as approved by the enforcement agency.

Mixed solid waste, from non-source separated recycling programs, in commercial compaction trucks. The only instance when this referenced waste can be accepted is with written authorization from City staff.

The facility cannot accept more than ten (10) percent putrescible material.

16. Self Monitoring:

The owner/operator shall submit the results of all self monitoring programs to the Enforcement Agency within 30 days of the end of the reporting period.

17. Enforcement Agency (EA) Conditions:

- a. The design and operation of the facility shall comply with all State Minimum Standards for solid waste handling and disposal as specified in Title 14 of the California Code of Regulations.
- b. The operator shall maintain a log of special/unusual occurrences. This log shall include, but is not limited to, fires, explosions, the discharge and disposition of hazardous or unpermitted wastes, and significant injuries, accidents or property damage. Each log entry shall be accompanied by a summary of any actions taken by the operator to mitigate the occurrence. The log shall be available to site personnel and the EA at all times.
- c. Additional information concerning the design and operation of the facility shall be furnished upon request and within the time frame specified by the EA.
- d. This permit is subject to review by the EA and may be temporarily suspended or revoked at any time by the EA for sufficient cause, in accordance with Division 30 of the Public Resource Code, Part 4, Chapter 4, Article 2, Sections 44305 et seq. and associated regulations.
- e. The EA reserves the right to suspend or modify waste receiving and handling operations due to an emergency, a potential health hazard, or the creation of a public nuisance.
- f. Any change that would cause the design or operation of the facility not to conform to the terms and conditions of this permit is prohibited. Such a change may be considered a significant change, requiring a permit revision. In no case shall the operator implement any change without first submitting a written notice of the proposed change, in the form of an RFI amendment, to the EA at least 180 days in advance of the change.
- g. The operator shall maintain a copy of the permit at the facility to be available at all times to facility personnel and EA personnel.
- h. Site traffic shall be controlled in such a manner as to minimize the contact between the public, public vehicles, commercial vehicles, and heavy equipment at all times.
- i. Hazardous waste found during the load checking process or sorting activity shall be either returned to the generator or placed in a hazardous waste bin by the end of the operating day.
- j. The maximum permitted daily tonnage for this facility is 100 tons per day, and shall not receive more than this amount without a revision of this permit.
- k. The EA reserves the right to request and receive from the operator any information that it deems necessary to conduct an inspection or to review and or write a Solid Waste Facility Permit.
