12. Legal Description of Facility:

The legal description of this facility is contained in page 1, Section A.2.A Location of the Joint Technical Document Addendum No. 4, dated February 2012. Approximately 82 acres within the E ½ of SE ¼ of Section 33 and approximately 80 acres within the W ½ of SW ¼ of Section 34, T4S, R15E, S.B.B.&M.

13. Findings:

- a. This permit is consistent with the Riverside County Integrated Waste Management Plan, which was approved by CalRecycle on September 23, 1998. The location of the facility is identified in the Countywide Siting Element, pursuant to Public Resources Code (PRC), Section 50001(a).
- b. This permit is consistent with the standards adopted by CalRecycle, pursuant to PRC 44010.
- c. The design and operation of the facility is consistent with the State Minimum Standards for Solid Waste Handling and Disposal as determined by the enforcement agency, pursuant to PRC 44009.
- d. The Riverside County Fire Department has determined that the facility is in conformance with applicable fire standards, pursuant to PRC, 44151.
- e. A Mitigated Negative Declaration for Environmental Assessment No.37549 was filed with the State Clearinghouse SCH #2000091072 on November 7, 2000, and was adopted by the Board of Supervisors on November 7, 2000. The Environmental Assessment describes and supports the design and operation which will be authorized by the issuance of this permit. A Notice of Exemption (NOE) 01-03 was filed with the County Clerk on April 13, 2001 and Notice of Exemption (NOE) 14-03 was filed with the County Clerk on March 12, 2014.

14. Prohibitions:

The permittee is prohibited from accepting the following wastes:
 Hazardous, radioactive, medical (as defined in Chapter 6.1, Division 20 of the Health and Safety Code), liquid, designated, or other wastes requiring special treatment or handling, except as identified in the Report of Disposal Site Information and approved amendments thereto and as approved by the enforcement agency.

16. Self Monitoring:

The owner/operator shall submit the results of all self monitoring programs to the Enforcement Agency within 30 days of the end of the reporting period (*for example, 1st quarter = January – March, the report is due by April 30, etc.. Information required on an annual basis shall be submitted with the 4th quarter monitoring report, unless otherwise stated.*)

17. Enforcement Agency (EA) Conditions:

- a. The operator shall comply with all State Minimum Standards for solid waste handling and disposal as specified in Title 27, California Code of Regulations.
- b. The operator shall maintain a log of special/unusual occurrences. This log shall include, but is not limited to, fires, explosions, the discharge and disposition of hazardous or unpermitted wastes, and significant injuries, accidents or property damage. Each log entry shall be accompanied by a summary of any actions taken by the operator to mitigate the occurrence. The log shall be available to site personnel and the EA at all times.
- c. Additional information concerning the design and operation of the facility shall be furnished upon request and within the time frame specified by the EA.
- d. The maximum permitted daily tonnage for this facility is 60 tons per day. No more than this amount shall be received without a revision of this permit.
- e. This permit is subject to review by the EA and may be suspended or revoked at any time by the EA for sufficient cause in accordance with Division 30 of the public Resource Code, Part 4, Chapter 4, Article 2, Section 44305.
- f. The EA reserves the right to suspend or modify waste receiving and handling operations due to an emergency, a potential health hazard, or the creation of a public nuisance.
- g. Any change that would cause the design or operation of the facility not to conform to the terms and conditions of this permit is prohibited. Such a change may be considered a significant change, requiring a permit revision. In no case shall the operator implement any change without first submitting a written notice of the proposed change, in the form of an RFI amendment, to the EA at least 180 days in advance of the change.
- h. A copy of this permit and the Joint Technical Document shall be maintained on site during open operating hours.
- i. The site shall maintain a formal hazardous waste monitoring program that is approved by this agency. The operator shall provide employee training to address the recognition and proper response to hazardous material incidents.
- j. The operator shall maintain and make available upon request for inspections for the enforcement agency and CalRecycle, all correspondence and reports provided to other regulatory agencies that have jurisdiction over the design and operations of the facility.
- k. A change in operational hours or days shall be subject to a two week written notification of and approved by the LEA.
