<ul style="list-style-type: none"> a) This permit is consistent with standards adopted by the Department of Resources Recycling and Recovery (CalRecycle) (Public Resources Code (PRC), Section 44010.) b) This facility is identified in the Non-Disposal Facility Element (NDFE) of the Countywide Integrated Waste Management Plan (approved by CalRecycle September 2013). (PRC Section 50001(a).) c) The Ramona Fire Department has determined that the facility is in conformance with applicable fire standards. (PRC Section 44151.) d) The design and operation of the facility is in compliance with the State Minimum Standards for solid waste handling for Transfer/Processing as determined by the LEA, based on a review of the May 2016 Report of Facility Information / Transfer Processing Report and an inspection conducted on June 30, 2016. e) In accordance with the California Environmental Quality Act (CEQA) Guidelines, Section 15096(f), the LEA has reviewed and considered the information regarding the environmental effects of this facility as contained in the Subsequent Mitigated Negative Declaration (SMND), SCH # 2005011002, dated January 2005 and certified by the County of San Diego Planning Commission on March 4, 2005. The LEA finds this permit action exempt under section 15301 Existing Facilities of the CEQA Guidelines. A Notice of Exemption will be filed with the County Clerk and the State Clearinghouse. 													
14. Prohibitions:													
The permittee is prohibited from accepting any liquid waste, sludge, non-hazardous waste requiring special handling, designated waste, or hazardous waste, untreated bio-hazardous waste, waste containing more than 50% water, friable and non-friable asbestos, large dead animals or parts thereof, and radioactive waste.

16. LEA Conditions:

The operator shall maintain a copy of this permit, Report of Facility Information and State Minimum Standards for Transfer Processing Station at the site at all times. 2. Any change that could cause the design or operation of the facility not to conform to the terms and conditions of this permit is prohibited. Such change may be considered a significant change, requiring a permit revision. In no case shall the operator implement changes without first submitting a written notice of the proposed change in the form of a Report of Facility Information (RFI) amendment to the LEA at least 180 days in advance of the proposed change. 3. Additional information related to compliance with this permit or information concerning the design and operation of this facility shall be furnished to the LEA upon request. 4. The SWFP is subject to review by the LEA and may be temporarily suspended or revoked at any time by the LEA for sufficient cause in accordance to Division 30 of PRC, Part 4, Chapter 4, Article 2, Section 44305 et seq. and associated regulations.

5. Stored recyclables shall not interfere with facility operations or cause a public health nuisance as determined by the LEA. The LEA reserves the right to reduce the maximum storage time of recyclables necessary to protect health or prevent a nuisance.
6. The operator shall maintain, and keep current, records of weight and types of waste received per day and per month. These records shall include the final disposition of transferred residual waste and recycled materials.
7. The operator shall maintain, and keep current, a record of all vehicles hauling waste to the facility.
8. The operator shall maintain a Log of special occurrences and a Log of complaints received.
9. The operator shall maintain a record of prohibited wastes discovered by the load check program and the final disposition of these wastes.
10. If the proposed dust control measures described in the Transfer Processing Report fail to adequately control dust from the operation of this facility, the LEA may require that additional measures be implemented.
11. The operator shall ensure that all waste handling activities are conducted within the transfer building.
