18 You are hereby notified that before an Administrative Law Judge a trial shall be held on

20 **Street, Suite 206, Oakland, California 94612**, or as soon thereafter as the matter may  
21 be heard, upon the charges made in the Statement of Issues for the Denial of the Minor  
22 Waste Tire Facility Permit served upon you. If you object to the place of hearing, you  
23 must notify the presiding officer within 10 days after this notice is served on you. Failure  
24 to notify the presiding officer within 10 days will deprive you of a change in the place of  
25 the hearing. You may be present at the hearing. You have the right to be represented  
26 by an attorney at your own expense. You are not entitled to the appointment of an  
27 attorney to represent you at public expense. You are entitled to represent yourself

1 without legal counsel. You may present any relevant evidence, and will be given full  
2 opportunity to cross-examine witnesses testifying at hearing against you. You are  
3 entitled to the issuance of subpoenas to compel the attendance of witnesses and the  
4 production of books, documents, or other things by applying to the Office of  
5 Administrative Hearings, 1515 Clay Street, Suite 206, Oakland, California 94612.  
6 Pursuant to section 11513 of the Government Code, parties are entitled, upon request,  
7 to be provided with the assistance of an interpreter if they do not proficiently speak or  
8 understand the English language. If you require the assistance of an interpreter; timely  
9 notice of this fact should be given to the agency conducting the hearing so that  
10 appropriate arrangements can be made.

12 CONTINUANCES: Continuances are not favored. If you need a continuance,  
13 write or call immediately to the Office of Administrative Hearings, 1515 Clay Street,  
14 Suite 206, Oakland, California 94612 (510) 622-2722. That agency has control of  
15 continuances. Requests coming less than 30 days before hearing, or a request without  
16 good cause, will be denied.
