SUBJECT: **Notice of Changes to Proposed Waste Tire Storage, Permit and Penalty Criteria Regulations (Second 15-Day Public Comment Period)**

The Department of Resources Recycling and Recovery (Department) proposes to make additional changes to previously proposed revisions to the *Waste Tire Storage, Permit and Penalty Criteria* regulations.

A 15-day public comment period for the proposed regulations began April 4, 2014 and ended April 18, 2014. After considering comments received during the first 15-day comment period, the Department modified the proposed regulations. The Department is now making the modified proposed regulations available for public review and comment during a second 15-day public comment period. **This second 15-day public comment period begins April 28, 2014 and ends May 12, 2014 at 5:00 PM.**

A copy of the full text of the regulations as originally proposed with the newly proposed changes clearly indicated is available on the Department's *Waste Tire Storage, Permit, and Penalty Criteria* webpage at: www.calrecycle.ca.gov/Laws/Rulemaking/WasteTires/default.htm (under *Rulemaking Documents*, see "Modified Proposed Regulations (Second 15-Day)"). The newly proposed changes are indicated in the text by italicized, bold, single underline (***single underline***) for an addition and italicized, bold, single strikethrough (***~~single strikethrough~~***) for a deletion. Department staff is only required to respond to comments related to the newly proposed changes to the regulations.

The newly proposed changes include reordering one subsection to make it standalone for clarity.
