
Dear Ms. Morgan:

I have received and considered your agency's request to extend the compliance schedule due date for Loyalton Landfill Facility by an additional ten months. The request is consistent with the provisions of Title 14, California Code of Regulations (CCR), Section 18365(b). The operator has made a good faith effort, and the LEA is taking appropriate enforcement if the LEA issues a revised Compliance Schedule.

Therefore, I hereby approve your request for the extension of the compliance schedule until July 31, 2015 with the understanding that the Compliance Schedule is revised. The LEA needs to update the Compliance Schedule to include updated milestones including, requiring the operator to submit an application for permit revision in time for the revision to be completed before the July 31, 2015 deadline. All necessary work shall be carried out in an expeditious manner to meet the proposed Compliance Schedule. The operator shall continue to submit the monthly status reports, to show all measurable progress being made to comply with the applicable requirements.

We appreciate your work in the matters of the Loyalton Landfill and in your commitment to partnership with CalRecycle staff.
