

- 1. Why does your jurisdiction need more time to meet the 50% goal? Describe why SRRE selected programs did not achieve 50% diversion. Identify barriers to meeting the 50% goal and briefly indicate how they will be overcome.**

The City of Paso Robles has experienced rapid growth. The 2000 census indicates a 31% increase in population from 1990, with much of the growth concentrated within the last three years. A new waste generation study is necessary to accurately count all residential, commercial and industrial recycling within the community.

The City is presenting a year 2000 diversion rate of 30% based upon the current ability to account for and document generation and diversion data. The biggest obstacle documenting 50% diversion is establishing an accurate count of the efforts in source reduction, reuse, and recycling occurring within the City. A Waste Generation Study for the year 2001 is proposed to commence in the first quarter of 2002. The generation study will provide the opportunity for staff to research the avenues of recycling and reuse that are taking place in the community that are not presently reporting, or that provide reports that are not acceptable to the approving authority. The generation study will also give an accurate look at the current waste generation rate, which is currently calculated by applying the approved scale factors for population change. These factors provide a relationship of waste growth to population growth that are accurate for moderate changes in population, but likely have diminished accuracy as the magnitude of growth increases. In addition, the City implemented a successful Economic Growth initiative that has altered the typical ratio of industrial-commercial-residential uses, and this can be accurately portrayed by a generation study.

The City implemented the majority of Programs identified in the SRRE. An example of a project that could not be implemented is the proposed materials recovery facility for the northern San Luis Obispo County region. This program projected 6,609 tons of recyclable materials to be diverted from the City wastestream by 2000. No such facility has been constructed in the North County, as it was presumed to be built in conjunction with the City of Atascadero and the County of San Luis Obispo. Due to the shortfall in consortium based activities available to the City, programs such as the MRF will need to be redirected to the City dedicated recovery programs. The time needed to plan, approve via City Council, and implement new and expanded programs is factored into the request for time extension.

2. Why does your jurisdiction need the amount of time requested? Describe any relevant circumstances in the jurisdiction that contribute to the need for a Time Extension.

In late 1999, the City of El Paso de Robles did a limited diversion study that showed how complex our wastestream was and identified potential diversion opportunities that were not being fully utilized. To gain more information about our wastestream, and in preparation to join the San Luis Obispo County Integrated Waste Management Authority, we are currently conducting a generation based analysis that will lead to the establishment of a new base-year.


Anticipating the results of the Waste Generation Study showing additional program implementation is needed, the City is concurrently planning two new programs scheduled for implementation in 2002. These programs are the Multi-Unit Residential Recycling and Wood Waste Recycling programs. Current Commercial and Industrial recycling programs are also being assessed for expansion as well, but as was explained in the need to establish a revised generation, current industrial achievements are not well documented nor understood. To adequately support and encourage participation in the above programs, the City will provide facilitated support such as enhanced outreach and educational programs to target the appropriate sectors. If needed, the City will also enact policy and/or ordinances to restrict disposal, and thereby encourage diversion.

Planning, funding and implementing the above changes will take a substantial amount of time to achieve, and will be planned sequentially.

3. Describe your jurisdiction's Good Faith Efforts to implement the programs in its SRRE.

The programs listed in the SRRE assigned to the City for implementation are active and ongoing (except multi-family residential recycling). Planning for new and expanded programs, described in item 2 and the waste generation study to be performed for year 2001 demonstrate the City's commitment to achieving or exceeding the 50% goal.


