09:44:27 16 Staff have developed several means of assistance.  
09:44:30 17Through a collaborative effort between program staff, IMB,  
09:44:35 18and public affairs, a comprehensive manual has been  
09:44:38 19prepared to explain the new program and each participant's  
09:44:40 20responsibility. This manual together with various forms  
09:44:45 21are being mailed this week to over 10,000 waste tire  
09:44:49 22generators, haulers, and in-users. We are hopeful that  
09:44:54 23this information will be comprehensive in explaining what  
09:44:57 24each of these party's needs to do beginning July the 1st.  
09:45:03 25 In addition, staff have scheduled training

09:45:05 1sessions in eight cities around the state during May and  
09:45:08 2June. At four of the locations there will be  
09:45:12 3presentations the Spanish. CalEPA will be assisting us by  
09:45:17 4conducting an additional session for Mexican haulers in  
09:45:19 5Tijuana. I have provided members a copy of the training  
09:45:24 6venues and the dates. And, again, I want to invite you

09:49:47 3 Background or history. At its March 2001 meeting  
09:49:54 4Board adopt the five-year plan for waste tire -- Board  
09:50:08 5adopted the five-year plan for waste tire recycling  
09:50:13 6amendment program and approved 200,000 for research in  
09:50:19 7devulcanization technology. On February, board approved  
09:50:24 8the scope of work and also directed staff to proceed with  
09:50:31 9a request for proposal and to procure a contractor to be  
09:50:37 10approved by the Board.  
09:50:39 11 The purpose of this contract is for the  
09:50:41 12contractor to conduct an investigation into the current  
09:50:47 13status of these technologies from bench SCORE laboratory  
09:50:53 14project to commercial industry SCORE plans. This study  
09:50:57 15were evaluated of the waste tire rubber devulcanization  
09:51:04 16technology. It is intend to obtain as much information  
09:51:09 17and data as possible and process operating parameters,  
09:51:17 18product properties, markets, cost benefit analysis and  
09:51:23 19environment impacts. The result of this evaluation will  
09:51:30 20provide information to assist Board in determining whether  
09:51:34 21to fund devulcanization project. The contractor will  
09:51:39 22prepare a report to be approved by the Board for  
09:51:43 23publication and put on Board's website.  
09:51:49 24 Finding. In five-year's plan the Board allocated  
09:51:52 25\$200,000 for this program.

09:51:58 1 An evaluation result. After Board approved the  
09:52:01 2scope of work, staff sent out request for proposal. Board  
09:52:08 3contractor unit received the full qualified proposal.  
09:52:14 4Three member of SCORE team evaluated the full proposal  
09:52:20 5independently according to the scoring criteria on the  
09:52:24 6proposed scoring sheet. To be qualified the proposals  
09:52:32 7much achieve a minimum score of 70 points. Two proposals  
09:52:37 8got over 70 points, were qualified. CalRecovery, Inc.,  
09:52:43 9got the highest score.

09:52:45 10 Staff proposes that CalRecovery is the contractor  
09:52:50 11for this contract in the amount of \$99,254. Staff  
09:53:03 12recommends that Board adopt Resolution Number 2003-278.

09:53:09 13 This ends my presentation.

09:53:12 14 CHAIRPERSON MEDINA: Thank you, Mr. Cheng for  
09:53:13 15your presentation.

09:53:14 16 Board members, any questions regarding this item?

09:53:17 17 DEPUTY DIRECTOR LEE: Mr. Chairman, one thing I  
09:53:18 18wanted to bring to your attention. Last week Mr. Faust --  
09:53:23 19Mr. Tom Faust of Redwood Rubber has filed a protest with  
09:53:27 20the Department of General Services protesting the award of  
09:53:31 21the devulcanization contract to CalRecovery. Mr. Faust  
09:53:34 22maintains his company should have been the successful  
09:53:37 23contractor but was not due to bias. DGS protest actions  
09:53:43 24can take several weeks. Because the funds for this  
09:53:45 25contract must be encumbered before the end of the fiscal

09:53:48 1year, the program staff and legal office recommends that  
09:53:51 2the Board take action on this matter today. Further, if  
09:53:53 3the Board approves the proposed contractor, the approval  
09:53:56 4should be made conditional on resolution of the protest by  
09:53:58 5DGS in favor of the Board.

09:54:03 7 Board Member Washington and the Board Member  
09:54:03 8Paparian.

09:54:05 9 COMMITTEE MEMBER WASHINGTON: Thank you,

09:54:07 11 Mr. Lee, in terms of the letter that the  
09:54:12 12gentleman sent from the rubber company, what was his  
09:54:15 13rationale for saying that he -- what's his reasoning  
09:54:20 14for --

09:54:28 15 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART:  
09:54:28 16 Martha Gildart with the Special Waste Division.

09:54:30 17 Tom Faust has in the past received grants from  
09:54:32 18this Board to conduct research into devulcanization and  
09:54:34 19has been a promoter of the ultrasonic version of  
09:54:38 20devulcanization. He has not been successful in that grant  
09:54:45 21project, however, had submitted a proposal to our request  
09:54:50 22for proposals claiming that he would be able to evaluate  
09:54:54 23all forums, all technologies for devulcanization. The  
09:54:59 24review panel did not feel his proposal addressed our need,  
09:55:03 25and he did not receive a passing score.

09:55:06 1 I believe he thinks his involvement in the  
09:55:09 2specific type of devulcanization technology qualifies him  
09:55:13 3uniquely to evaluate all types. But he is not here today  
09:55:17 4to speak for himself.

09:55:21 5 COMMITTEE MEMBER WASHINGTON: Yeah. I guess  
09:55:21 6that's the problem I have. He didn't show them.

09:55:28 7 CHIEF COUNSEL TOBIAS: If I may, this protest now  
09:55:30 8moves to DGS. So I think that any other discussion if you  
09:55:34 9want to discuss it further would be better done in closed  
09:55:37 10session. I think it's -- it should suffice -- and I don't  
09:55:41 11mind discussing the closed session so I don't want to  
09:55:44 12leave that impression. But I think it probably is  
09:55:48 13sufficient to deal with the grant proposal the way it is.  
09:55:52 14And then it's conditional. So if DGS should find that  
09:55:57 15there was a basis for his protest, then we would be coming

09:56:10 21 CHIEF COUNSEL TOBIAS: Contract. Sorry. Thank  
09:56:11 22you, Martha.

09:56:13 23 CHAIRPERSON MEDINA: Board Member Paparian.

09:56:14 24 COMMITTEE MEMBER PAPARIAN: Separate issue.

09:56:16 25Mr. Levielle's newsletter reported that somebody else

09:56:20 1complained that one type of devulcanization technology was  
09:56:24 2not part of the scope of this project. Did you read that?  
09:56:29 3I don't remember what the technology was. But do you have  
09:56:33 4a response to that?

09:56:34 5 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART: I  
09:56:34 6received communications from Snow Hume with Champion  
09:56:38 7Rubber. He is in the rubber reclamation business. He was  
09:56:41 8concerned in the RFP we cited three specific types of  
09:56:46 9devulcanization technology. However, the citation was not  
09:56:48 10exclusive to just those three. He brought to our  
09:56:51 11attention microbial degradation of the sulfur carbon bonds  
09:56:57 12in vulcanized rubber. And our belief is the wording of  
09:57:03 13the RFP was broad enough that all viable forms of  
09:57:04 14devulcanization can be examined under this contract so  
09:57:08 15microbial degradation could be.

09:57:11 16 COMMITTEE MEMBER PAPARIAN: If that has some  
09:57:12 17viability, it could be examined?

09:57:16 18 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART:  
09:57:16 19Correct. It could be examined.

09:57:17 20 CHAIRPERSON MEDINA: Board Member Jones.

09:57:19 21 COMMITTEE MEMBER JONES: Mr. Chair, we did  
09:57:20 22receive a letter from RMA saying that the folks from  
09:57:25 23Goodyear who have done the majority of the work -- I think

10:00:09 24members of the Board. My name is Stacey Patenaude. I

10:00:09 25work in the Special Waste Division. I'm here to present

10:00:12 1the item for the consideration for contractor of the  
10:00:13 2Engineering environmental services contract.  
10:00:15 3 I'd like to give you a brief presentation on the  
10:00:18 4work that we have completed with this contract and our  
10:00:22 5proposed course of action over the next couple years with  
10:00:25 6this contract.

10:00:30 7 (Thereupon an overhead presentation was  
10:00:30 8 presented as follows.)

10:00:30 9 MS. PATENAUDE: Previous projects completed under  
10:00:43 10this contract, first one was the Dixon Landing interchange  
10:00:47 11project in which 660,000 tires were used as lightweight  
10:00:51 12fill in San Jose. This is a cooperative agreement with  
10:00:54 13CalTrans. This project saved the State of California  
10:00:57 14approximately quarter-million-dollars over using  
10:01:00 15conventional lightweight film.

10:01:04 17 MS. PATENAUDE: Another project that was done in  
10:01:06 181999 was vibration attenuation test pad that we completed  
10:01:11 19through this contract with subcontractors hired through

10:01:20 21Gray Test Landfill. This was to evaluate the energy  
10:01:24 22absorption characteristics of tire shreds.

10:01:30 25Transit Authority in conjunction with the Waste Board

10:01:43 3 did all the rest. And Dr. Dana Humphreys and our  
10:01:51 4 acoustical engineer Wilson Eric did the monitoring of

10:01:54 8 studies, Valley Transit Authority chose to use this as

10:27:01 21since many of the properties were cleaned up under the  
10:27:05 22program were owned by the local government, which are  
10:27:08 23right-of-ways, easements, alleyways, those kinds of  
10:27:10 24things, the Board does not typically pursue cost recovery  
10:27:13 25against those sites, but, however, the local government

10:27:15 1will also propose on occasion to clean up privately-owned  
10:27:18 2property.

10:27:21 3           And herein lies a problem. So even though the  
10:27:24 4Board awards the grants, the local governments -- but they  
10:27:27 5cleanup privately-owned property, we are required by law  
10:27:30 6to pursue cost recovery from those land owners to the  
10:27:34 7extent it's feasible to do so. And, of course, the  
10:27:37 8problem that we have with doing that is that many of these  
10:27:40 9sites are located in fairly remote areas of the state.  
10:27:43 10And some of the land owners do not live on the land, they  
10:27:49 11are victims of unauthorized illegal dumping.

10:27:52 12           Historically what we found through our own  
10:27:53 13cleanup program is that sites under 5,000 tires can be  
10:27:57 14extremely expensive to clean up, especially if they're in  
10:28:00 15these remote areas. Typically what we do in those  
10:28:04 16situations, we try to combine some of the smaller sites to  
10:28:07 17maximize our costs and also our resources by doing them  
10:28:10 18all together at the same time.

10:28:15 19           COMMITTEE MEMBER WASHINGTON: Excuse me,  
10:28:15 20Mr. Chairman. Can we -- in issuing these grants, can  
10:28:19 21we -- what's the word I'm looking for? Can we tell local  
10:28:24 22governments they can't issue this money to private owners?  
10:28:31 23I mean, can the Board say that as a grantee you cannot  
10:28:37 24issue this money to private land owners?

10:28:41 25           SPECIAL WASTE DIVISION SUPERVISOR FUJII: You

10:28:42 1know, legal can chime in on this, but I don't believe we  
10:28:45 2would have the authority to tell -- we can tell them if  
10:28:50 3you spent the money on this privately-owned property, this  
10:28:54 4Board would recover those costs, as opposed to a  
10:28:57 5publicly-owned property where the Board would not pursue  
10:29:00 6that cost recovery under that granted. So I guess the  
10:29:05 7answer to the question is we would probably not do that.  
10:29:07 8We would tell them if you spend the money on a privately  
10:29:10 9owned property, that's what this policy is about.

10:29:14 10 COMMITTEE MEMBER WASHINGTON: These grants are  
10:29:14 11issued to local government; is that correct?

10:29:17 12 SPECIAL WASTE DIVISION SUPERVISOR FUJII:  
10:29:17 13 Correct.

10:29:17 14 COMMITTEE MEMBER WASHINGTON: So you're saying  
10:29:18 15when we issue the grants to local government, we can't say  
10:29:21 16to the local government what you can spend it on.

10:29:25 17 SPECIAL WASTE DIVISION SUPERVISOR FUJII: Well, I  
10:29:25 18don't believe that in the way that the application is  
10:29:28 19written that we've done that. And I suppose if we receive  
10:29:32 20direction from the Board to do that, we would do that.  
10:29:35 21But today we have not done that.

10:29:38 22 CHAIRPERSON MEDINA: And can we hear from legal  
10:29:40 23counsel on that? Counsel.

10:29:42 24 CHIEF COUNSEL TOBIAS: I would agree with what  
10:29:44 25staff's saying.

10:29:48 1 COMMITTEE MEMBER JONES: Didn't we get put in a  
10:29:49 2secondary position -- I'm sorry.

10:29:51 3 CHAIRPERSON MEDINA: Board Member Jones.

10:29:53 4 COMMITTEE MEMBER JONES: We did a tire clean up  
10:29:54 5through a local government where we got put into a  
10:29:56 6secondary position for cost recovery, and they never did  
10:30:00 7any cost recovery. So how can we say we never did that.  
10:30:05 8We actually did do that.

10:30:07 9 CHIEF COUNSEL TOBIAS: I think generally what  
10:30:09 10we're saying -- the answer to the question Mr. Washington  
10:30:11 11said was that he asked whether or not we could not give it  
10:30:16 12to private property. And certainly the Board could make a  
10:30:20 13policy saying that. But generally the way -- following  
10:30:24 14Board policy at this point, the way we would do it is to  
10:30:28 15say if there is private property right now, the Board  
10:30:31 16policy is cost recovery. That's what this item is about  
10:30:34 17is basically saying there are certain circumstances which  
10:30:39 18staff is proposing to give grants where there would not be  
10:30:44 19cost recovery. That's the reason this item is coming up  
10:30:47 20the way it is because it would be a deviation from our  
10:30:50 21current policy, which is to pursue cost recovery in all  
10:30:53 22situations.

10:30:55 23 COMMITTEE MEMBER JONES: But when we're giving  
10:30:56 24grants to local governments to do the clean up and then  
10:31:00 25Board members asked staff how do we do on cost recovery,

10:31:06 1we didn't do cost recovery because it was in the hands of  
10:31:10 2local government. They didn't pursue cost recovery.  
10:31:12 3So -- and it was like -- I think I remember at the time we  
10:31:16 4didn't have -- you know, we didn't have a standing in that  
10:31:19 5issue.

10:31:20 6 CHIEF COUNSEL TOBIAS: So that's why we're  
10:31:22 7bringing this forward now is to clarify what that  
10:31:25 8situation is.

10:31:26 9 If the Board would like to continue to do cost  
10:31:28 10recovery on every grant that goes out on private property,  
10:31:35 11then that is the current policy. The problem is that the  
10:31:41 12local governments according -- and this is what the staff  
10:31:44 13report says, is that local governments in some of these  
10:31:48 14limited cases that are being proposed in this agenda item  
10:31:52 15do not want the grants. They will not go out and pick  
10:31:55 16them up unless they don't have to do cost recovery.

10:32:01 17And so you'll notice -- and this is kind of getting ahead  
10:32:07 18of Bob's staff report. But on page 3-3 you'll see where  
10:32:11 19there's some very limited circumstances that staff is  
10:32:13 20proposing to not do cost recovery in those circumstances  
10:32:19 21where it's in a remote area and that it would be very  
10:32:24 22difficult to do the tires otherwise, where there's a  
10:32:30 23number of overlapping sites, or where there's some  
10:32:39 24incidental clean up on private property next to roads.

10:32:40 25 So in one situation, you're right. We did end up

10:32:43 1in that situation. When this item came forward, staff was  
10:32:49 2proposing these limited circumstances, and that's why  
10:32:54 3staff and program staff and the legal staff agreed that we  
10:32:58 4needed to bring this to the Board and get clarification on  
10:33:00 5it.

10:33:01 6 So the options today are to basically approve  
10:33:05 7some limited circumstances to enhance this program and to  
10:33:09 8get better subscription to it, if you will, or to  
10:33:12 9basically say no, we don't want to do that and keep it the  
10:33:16 10way it is, in which case that will limit some of those  
10:33:19 11clean ups. So does that -- that might be more than you  
10:33:24 12wanted to know, but I'm trying to put this together.

10:33:28 13 CHAIRPERSON MEDINA: Any inclination in regard to  
10:33:29 14this item because of the -- I guess the various  
10:33:33 15considerations -- and I think this is an item that merits  
10:33:40 16full Board discussion from my perspective. I would just  
10:33:45 17rather move this so we have a discussion before the full  
10:33:49 18Board on this. I think it's a very serious issue. It  
10:33:53 19gives us at least another week to go over this.

10:33:56 20 Board Member Washington.

10:33:57 21 COMMITTEE MEMBER WASHINGTON: I guess, Mr. Chair,  
10:33:58 22I raised that because when I read the history of this and  
10:34:01 23it says, "The purpose and scope of this tire grant program  
10:34:03 24is for local governments at the local government waste  
10:34:07 25tire clean up provides funding for local governments to

10:34:10 1remove, transport, or reuse or disposal of waste tires  
10:34:14 2from stockpiles and nuisance dumping in the community  
10:34:19 3statewide." And then when I go down and read "A  
10:34:21 4substantial portion of this grant is awarded to local  
10:34:24 5governments to abate illegal tire disposal sites that are  
10:34:28 6located along roadsides and other public right-of-ways,"  
10:34:33 7public right-of-ways are not in private community. That's  
10:34:36 8the concern I have. If there's some clarification to  
10:34:38 9that, I think we need to be clearer on this what might do.  
10:34:42 10I don't have a problem. I just want to make sure we're  
10:34:45 11clear on what this grant is used for and that we're not  
10:34:48 12just out allowing local governments to use money because  
10:34:51 13someone comes in and says, "I have a legacy tire site in  
10:34:53 14my backyard, can you come clean it up."

10:34:57 15 CHIEF COUNSEL TOBIAS: Mr. Medina, can I finish  
10:34:59 16answering the question?

10:35:00 17 CHAIRPERSON MEDINA: Go ahead.

10:35:01 18 CHIEF COUNSEL TOBIAS: Mr. Washington, I think  
10:35:02 19that's precisely what this item is about. What we were  
10:35:05 20concerned is that you would have an inequity, that exactly  
10:35:08 21that would happen. That somebody -- one of the local  
10:35:10 22governments would basically clean up a good-size pile, not  
10:35:16 23pursue cost recovery, and then our program would be going  
10:35:19 24after very similar piles and we would be pursuing cost  
10:35:23 25recovery.

10:35:24 1 So your question is answered on page 3-3 in  
10:35:30 2number 3 where basically it says that to a great extent  
10:35:33 3that is what a lot of the grants are used for is to clean  
10:35:37 4up rights-of-way and other public areas that do get, you  
10:35:43 5know, public dumping. What we're saying in that  
10:35:45 6particular circumstance is where you get dumping in a  
10:35:48 7public right-of-way and there's a small amount -- and that  
10:35:52 8key is small amount -- that spills over -- we use the word  
10:35:55 9incidental to mean that if you have a big pile on a  
10:35:58 10private piece of property some of it happens to be on the  
10:36:01 11roadway, that would not qualify. The majority of the  
10:36:05 12tires have to be on the public right-of-way with a small  
10:36:08 13amount of spillover to private property. We would assume  
10:36:12 14in that situation that the property owner was not  
10:36:14 15responsible if most of the tires were on the right-of-way.  
10:36:18 16Because property owners in this situation would have to  
10:36:20 17turn over an affidavit that says they are not -- under  
10:36:23 18penalty of perjury, they were not responsible for the  
10:36:25 19tires being there.

10:36:28 20 Does that help answer your question?

10:36:30 21 Mr. Medina, I don't if staff -- it might be  
10:36:32 22helpful to hear any other questions that Board members  
10:36:35 23have so we could get ready to answer.

10:36:38 24 CHAIRPERSON MEDINA: I'm getting ready to hear  
10:36:41 25from Board Member Jones. I have not cut off discussion of

10:36:44 1this item yet.

10:36:44 2 Board Member Jones.

10:36:44 3 COMMITTEE MEMBER JONES: Thank you, Mr. Chair.

10:36:49 4 I have a problem with this agenda item because I

10:36:52 5think that it's also preemptive of any discussion that

10:36:55 6we're going to have on Sonoma. I think it's a clear

10:36:59 7tactic to limit the Board's discretion in how we deal with

10:37:06 8the Sonoma tire piles by quantifying exactly in this

10:37:11 9agenda item where we have discretion. And I think while

10:37:15 10that's pretty slick, I think it is not fair. It's

10:37:21 11definitely not fair to my efforts over the last two years

10:37:25 12or Mr. Medina's or other members who have tried to solve

10:37:29 13that Sonoma pile tire, which -- tire piles, which were put

10:37:34 14there in the 50s as legitimate erosion control and now

10:37:40 15have to come out. And we're trying to work on a thing to

10:37:43 16fix it.

10:37:43 17 And it's pretty clear that Ms. Tobias and I don't

10:37:47 18agree on the method to do that. And I see this policy as

10:37:52 19a direct slam to stop that. And it's okay to laugh about

10:37:57 20it, but I've been dealing with lawyers for about 20 years.

10:38:01 21And that's how I feel. Because you've made it very clear

10:38:05 22that if anybody has ever had knowledge in this thing for

10:38:09 23all cases, private property owners must sign a declaration

10:38:12 24under penalty of perjury that they didn't personally bring

10:38:16 25the tires on site, didn't profit from the placement, nor

10:38:19 1did they direct, authorize, license, permit, lease legally  
10:38:24 2or illegally or otherwise provide consent to another to  
10:38:27 3bring the tires on site.

10:38:29 4           Sonoma was -- if all of the things that we know  
10:38:33 5about Sonoma, in the 50s a reasonable way to deal with  
10:38:41 6erosion was the use of tires. Those people now are being  
10:38:46 7asked to remove those tires by this Board. I have no  
10:38:48 8problem with that. But I sure do have a problem when I'm  
10:38:55 9told by legal that I have no remedy except to take their  
10:38:58 10farms. And I'm not in a position to take a family farm  
10:39:05 11for a system that had been acknowledged statewide as a way  
10:39:09 12to deal with remediation.

10:39:11 13           I'm sure as heck not going to be with a policy  
10:39:14 14while under the -- to deal with one issue that could, in  
10:39:19 15effect, stop us from any alternatives in another issue.  
10:39:24 16That's how I see this item.

10:39:25 17           So that's my question. Does this do that?

10:39:29 18           CHIEF COUNSEL TOBIAS: It's not intended to do  
10:39:30 19that, nor do I think it does that. I certainly think that  
10:39:34 20you can -- the Board can make it clear that this in no way  
10:39:38 21applies to Sonoma. I think we have a Sonoma tire item  
10:39:42 22coming forward that has all the options open for the  
10:39:44 23Board.

10:39:45 24           This one arises out of a long-standing situation  
10:39:48 25which actually you just referred to where we did have a

10:39:53 1local government do the clean up. They did not pursue  
10:39:57 2cost recovery, and that ended up being a problem and  
10:40:00 3contrary to the Board's policy.

10:40:02 4           So the reason this is in front of you today is  
10:40:04 5that there are some very limited circumstances that staff  
10:40:08 6has been able to delineate that would allow these piles to  
10:40:15 7be cleaned up where they're very unlikely to be cleaned up  
10:40:20 8by us or anyone else.

10:40:21 9           So as far as I'm concerned from a legal  
10:40:23 10standpoint, and I think program, from a program  
10:40:24 11standpoint, is that this is limited to the local tire  
10:40:28 12grants in this situation. And I think it would be  
10:40:31 13relatively simple to say if you do suspect that's the  
10:40:36 14case, which I can assure you was not, that this does not  
10:40:40 15apply to the Sonoma situation. So I think that's a fairly  
10:40:43 16easy fix if that's a concern.

10:40:49 17           But it's actually a long-standing problem. It's  
10:40:53 18come up because I think staff is concerned that we don't  
10:40:56 19have a way of getting these other tires picked up and  
10:41:00 20really it doesn't have anything to do with the Sonoma  
10:41:04 21situation.

10:41:04 22           CHAIRPERSON MEDINA: Thank you, again.

10:41:05 23           Because of all of the Board members' interest in  
10:41:08 24this area and because we will be engaging in some full  
10:41:14 25Board discussions in regard to issues that arise, I want

10:41:18 1to thank the legal staff for adding to the discussion in  
10:41:23 2regard to this area. My inclination just on instinct  
10:41:27 3tells me I should move this to the full Board without any  
10:41:32 4recommendation at this Committee so all of the Board  
10:41:35 5members can have an opportunity to discuss this in full.  
10:41:38 6So unless I hear otherwise, then this item will be moved  
10:41:42 7to the full Board for discussion.

10:41:45 8           And do I need a motion for that? Okay. Then  
10:41:49 9this -- as a Chair, I will move this to the full Board for  
10:41:56 10discussion.

10:41:57 11           DEPUTY DIRECTOR LEE: Thank you, Mr. Chairman.

10:41:58 12           Board Item 13, Committee Item G is consideration  
10:42:01 13of the grant awards for the local government waste tire  
10:42:03 14cleanup grant program for Fiscal Year 2002/2003. As we've  
10:42:08 15just discussed, there may be some other issues that we  
10:42:14 16attempted to address in Board Item 29 that may bear on  
10:42:16 17your -- any determination you make on Board Item 13.

10:42:20 18           What's the Committee's pleasure with regards to  
10:42:23 19hearing this measure now or moving that to the full Board?

10:42:29 20           CHAIRPERSON MEDINA: I think at this point we  
10:42:31 21will take a 10-minute break.

10:42:35 22           (Thereupon a recess was taken.)

10:58:33 23           CHAIRPERSON MEDINA: This meeting is called back  
10:58:35 24to order.

10:58:36 25           Members, any ex partes?

10:58:37 1 Board Member Jones.

10:58:39 2 COMMITTEE MEMBER JONES: Thanks, Mr. Chair.

10:58:39 3 Chuck Helget, and I think that was it.

10:59:28 19 DEPUTY DIRECTOR LEE: Thank you, Mr. Chairman.

10:59:29 20Move on to Board Item 14, Committee Item H, discussion and

10:59:32 21request for direction on consumer education tire survey

10:59:36 22and marketing research contract, tire recycling management

10:59:39 23fund, Fiscal Year 2001/2002.

10:59:41 24 Elena Yates will make the staff presentation.

10:59:44 25 MS. YATES: Good morning, Committee Chair and

10:59:47 1Board members. I'm Elena Yates from the Waste Tire  
10:59:48 2Diversion Section of the Special Waste Division. This  
10:59:50 3presentation is for Committee Item H, discussion and  
10:59:53 4request for direction on the consumer education tire  
10:59:56 5survey and market and research contract tire recycling  
11:00:00 6management fund, Fiscal Year 01/02.

11:00:03 7           At its March 2001 meeting, the Board approved the  
11:00:10 8five-year plan for the waste tire management program. The  
11:00:10 95 year plan allocated 250,000 in Fiscal Year 01/02 to  
11:00:15 10conduct a survey of consumer knowledge of tire maintenance  
11:00:20 11and disposal and develop an informational brochure and  
11:00:24 12\$350,000 in Fiscal Year 02/03 to develop and provide  
11:00:28 13public service announcements based on the survey results.

11:00:32 14           The Board at its February 2002 meeting directed  
11:00:36 15staff to revise the scope of work for the consumer  
11:00:38 16education tire survey brochure and public service  
11:00:41 17announcements contract to exclude the development of a  
11:00:45 18brochure in this phase and to submit the revisions at its  
11:00:48 19March 2002 Board meeting for award of contract.

11:00:51 20           The survey and market and research was focused on  
11:00:55 21developing baseline of current public knowledge of tire  
11:00:59 22maintenance, disposal, the purchasing of longer-lasting  
11:01:01 23tires, and recycling waste content product available to  
11:01:06 24consumers and businesses. The literature review, baseline  
11:01:10 25survey, and market and research will provide the Board

11:01:12 1with the information necessary to determine the type of  
11:01:14 2media outreach campaign that would be most effective.

11:01:21 3           Although the contractor has not completed Task C,  
11:01:22 4conduct marketing research and analyze the results in its  
11:01:29 5entirety, they have completed a summary of the finding of  
11:01:30 6the focus groups and their preliminary data from the  
11:01:34 7statewide phone survey.

11:01:36 8           I'd like to introduce the representative from  
11:01:37 9Chico State, Dr. James Fletcher, who will present the  
11:01:41 10preliminary finding on Task C of the survey. Thank you.

11:01:46 11           CHAIRPERSON MEDINA: Thank you, Ms. Yates for  
11:01:47 12that presentation.

11:01:50 13           DR. FLETCHER: Good morning. I think we have a  
11:01:53 14packet for each of you that contains the Power Point  
11:01:57 15slides, the literature review, the executive summary from  
11:02:00 16the focus groups and the telephone questionnaire in  
11:02:04 17English that we are currently using for data collection.

11:02:09 18           (Thereupon an overhead presentation was  
11:02:09 19           presented as follows.)

11:02:09 20           DR. FLETCHER: The objectives of the study that  
11:02:12 21we're conducting consist of four items. One is to look at  
11:02:17 22consumer knowledge concerning products derived from  
11:02:21 23California waste tires. The second is to assess  
11:02:24 24consumers' knowledge regarding proper tire maintenance and  
11:02:27 25maintenance practices. Third was to look at various legal

11:02:32 1tire disposal options and consumer knowledge of those.

11:02:35 2And the fourth was consumer knowledge concerning factors

11:02:38 3that influence purchases for new tires.

11:02:09 4 --o0o-

11:02:09 5 DR. FLETCHER: The research consists of three

11:02:44 6parts. One is the literature review which you have a copy

11:02:47 7of in front of you, in-depth literature review. The

11:02:50 8second was a series of focus groups conducted the five

11:02:53 9languages. And the third was a telephone survey that is

11:02:56 10in the process now of being conducted in five languages.

11:02:09 11 --o0o-

11:02:09 12 DR. FLETCHER: The literature review objectives

11:03:01 13were to provide background knowledge to the research team

11:03:04 14regarding prior research. In other words, we didn't want

11:03:06 15to reinvent the wheel. We want to have a clear

11:03:10 16understanding of the research that's been done. We want

11:03:12 17to build on that research with our research.

11:03:14 18 Second was to identify topics and issues that

11:03:16 19were relevant to be included in the focus groups and the

11:03:19 20telephone survey to aid us in the development of the focus

11:03:22 21group topics and questions that we included as well as the

11:03:26 22telephone survey.

11:03:27 23 And last, to find information that would be

11:03:29 24useful in the communications efforts that will be the next

11:03:32 25phase of the project.

11:02:09 1 --o0o-

11:02:09 2 DR. FLETCHER: The literature review included

11:03:38 3extensive research using electronic databases and mobile

11:03:46 4search engines.

11:02:09 5 --o0o-

11:02:09 6 DR. FLETCHER: He did very in-depth research on

11:03:51 7specific websites including the Rubber Manufacturer's

11:03:53 8Association, CalEPA, Integrated Waste Management Board

11:03:58 9website, and Goodyear Rubber and Tire Company. In

11:04:01 10addition, he conducted direct communications, in-depth

11:04:05 11interview with 13 individuals, one of whom is Dan

11:04:10 12Zielinski, Vice President of the Rubber Manufacturer's

11:04:13 13Association, for just an example.

11:02:09 14 --o0o-

11:02:09 15 DR. FLETCHER: We had several key findings from

11:04:18 16literature review. One is that some information is

11:04:22 17available that addresses consumer knowledge of tire and

11:04:24 18maintenance and tire safety that's out there in the

11:04:28 19literature that's research that's been previously done.

11:04:30 20We found a few reports available that indicate that

11:04:34 21consumers know little about proper tire maintenance and

11:04:38 22care. A AAA report conducted in 1999 found that 48

11:04:42 23percent of the respondents to their survey incorrectly

11:04:44 24consulted tire side wall for recommended tire air pressure

11:04:49 25rather than the manual or the door on the car that posts

11:04:53 1the proper tire pressure.

11:04:55 2 In 2001 the National Highway Traffic Safety

11:04:59 3report found that 33 percent of passenger cars and light

11:05:04 4trucks have at least one significantly underinflated tire,

11:05:07 5and 9 percent have a bald tire. The Rubber Manufacturers

11:05:10 6Association study that was done in 2002 found that

11:05:13 7basically consumers are not doing a very good job of

11:05:16 8maintaining their tires.

11:02:09 9 --o0o-

11:02:09 10 DR. FLETCHER: There's very limited information

11:05:22 11available regarding studies out there. A 1992 study by

11:05:26 12the National Highway Traffic Safety Administration found

11:05:30 13that most tires were familiar with UTQGS and FMVSS

11:05:40 14information. A 1999 study by the tire review and 2002

11:05:42 15tire business studies found that in-store salespersons

11:05:46 16were a very important source of information for consumers.

11:05:49 17I'll talk a little bit later, but I'll mention right now

11:05:53 18our focus groups found this to be not necessarily true,

11:02:09 3 DR. FLETCHER: There's no prior research we found  
11:06:29 4regarding consumer attitude, perception, and knowledge  
11:06:31 5about tire recycling and disposal. And marketing  
11:06:34 6communication efforts have focused on tire safety and  
11:06:37 7maintenance very recently primarily because of the  
11:06:41 8Firestone publicity.  
11:02:09 9 --o0o-  
11:02:09 10 DR. FLETCHER: So basically the findings from the  
11:06:46 11literature review that public efforts have been done to  
11:06:48 12help consumers understand -- help us understand how  
11:06:50 13consumers make tire decisions.  
11:06:54 14 Second, there's limited information about  
11:06:57 15consumer knowledge of tire safety and maintenance, and  
11:06:59 16we're focusing heavily on that in our survey. Perhaps no  
11:07:05 17studies have been conducted that investigate consumers'  
11:07:08 18knowledge of tire recycling disposal practices. No prior  
11:07:11 19research on differences based upon ethnicity which is one  
11:07:16 20of the deficiencies we found in the literature review,  
11:07:20 21that they're general population surveys and they've really  
11:07:23 22not focused in on specific ethnic groups to find out if  
11:07:26 23there's specific differences among ethnic groups and their  
11:07:29 24purchase decisions, their knowledge of tire maintenance,  
11:07:32 25et cetera.

11:07:32 1 And the last thing is the literature review  
11:07:35 2clearly indicates a need for research to facilitate a  
11:07:38 3systematic development of our focus group and our survey  
11:07:41 4questions. It's extremely helpful to us.

11:02:09 5 --o0o-

11:02:09 6 DR. FLETCHER: We conducted five focus groups,  
11:07:47 7three on February 5th and two on February 6th in five  
11:07:51 8languages, English, Spanish, Mandarin, Vietnamese, and  
11:07:53 9Tagalog. There were 59 participants in the focus groups;  
11:07:59 1039 males and 20 females.

11:02:09 11 --o0o-

11:02:09 12 DR. FLETCHER: Some of the main topic areas  
11:08:05 13covered were information about recent tire purchases. The  
11:08:08 14reason we use recent tire purchases is because that's the  
11:08:11 15information people are going to have the best recall.  
11:08:14 16Tire purchasing criteria, knowledge and behaviors related  
11:08:17 17to tire maintenance and safety. How often do they check  
11:08:20 18their tires. How often do they rotate, balance their  
11:08:23 19tires, have their front end on their car aligned.  
11:08:25 20Knowledge of tire recycling and disposal, and lastly, any  
11:08:29 21familiarity they had with tire recycling and disposal  
11:08:32 22information campaigns.

11:02:09 23 --o0o-

11:02:09 24 DR. FLETCHER: As far as recent tire purchase  
11:08:37 25information, they said that many of them were prompted by

11:08:40 1 concerns for wear and safety. Some were planned. They  
11:08:44 2 went out. They did their research. They looked at how  
11:08:47 3 many miles they had driven or how long they had their  
11:08:51 4 tires and they actually did some prior purchase planning  
11:08:54 5 and then went out and purchased their tires. Others said  
11:08:58 6 that, as would be expected, many were unplanned purchases.  
11:09:02 7 They noticed by chance they had unusual wear on maybe  
11:09:06 8 caused by misalignment of the front end or by a tire being  
11:09:11 9 out of balance. Others had a problem with a tire going  
11:09:14 10 flat and inspecting the tire and feeling they need to be  
11:09:16 11 replaced.

11:02:09 12 --o0o-

11:02:09 13 DR. FLETCHER: Some of the tire purchased  
11:09:22 14 criteria that were considered by consumers is, number one,  
11:09:26 15 price was a big consideration that was repeated over and  
11:09:29 16 over again. Where they could get the best price. Others  
11:09:32 17 also considered convenience of the dealer location. That  
11:09:35 18 was not important in terms of the purchase but in terms of  
11:09:39 19 maintenance, having the tires rotated, having the front  
11:09:42 20 end aligned, et cetera. And another important criteria  
11:09:46 21 particularly among ethnic minorities is recommendation of  
11:09:47 22 friends and family. The credibility of a dealer -- not  
11:09:51 23 coming from the dealer but coming from other people they

11:11:14 1important was price. Everybody was talking about getting

11:02:09 4 DR. FLETCHER: Some of the consumers said they  
11:11:23 5were willing to pay higher price to get the tires they  
11:11:25 6wanted. Others said that low price might be a reflection  
11:11:29 7of poor quality and were sometimes hesitant to buy  
11:11:33 8lower-priced tires even if they were on sale. Many  
11:11:37 9acknowledge being on budgets. They tried to get the best  
11:11:40 10value for the amount of money they had to spend for their  
11:11:44 11tires.

11:02:09 12 --o0o-

11:02:09 13 DR. FLETCHER: Expectations regarding tire life.  
11:11:47 14Warranty was important. People considered the warranty as  
11:11:52 15being a reflection of potential tire life. Some people  
11:11:57 16looked at it in terms of miles. Others looked at it in  
11:12:00 17terms of year. That largely depended on the driving  
11:12:02 18habits. If people didn't drive a lot of miles, the  
11:12:05 19deterioration of the tire because of aging was more a  
11:12:07 20consideration, whereas people that drove a lot of miles  
11:12:10 21each year were more concerned about the miles they could  
11:12:13 22expect to get from the tires.

11:12:15 23 Consumers acknowledged that tire life is clearly  
11:12:17 24linked to driving habits, driving conditions, and tire  
11:12:20 25maintenance. Their opinions were divided about the

11:12:24 1importance of high mileage and road hazard warranties.

11:12:28 2But it depended, again, on the types of driving that the

11:12:31 3particular consumers were doing.

11:12:34 4 In summary, consumers describe good value as

11:12:39 5getting the characteristics they wanted, the ones I just

11:12:41 6mentioned, together with a competitive or reasonable price

11:12:45 7or price they could afford.

11:02:09 8 --o0o-

11:02:09 9 DR. FLETCHER: The majority of consumers said

11:12:50 10they knew what the recommended tire pressures were on

11:12:53 11their tires. However, many of them thought that the tire

11:12:58 12pressure was on the side of the tire and was established

11:13:01 13by the manufacturer. Some did, in fact, know that they

11:13:03 14would consult the owners manual or the frame of the

11:13:07 15drivers door. But as was confirmed in the literature

11:13:11 16review, of course, by our focus groups, many of the

11:13:13 17consumers do not know. They look at the side of the tire,

11:13:17 18and they adjust their tire pressure based on that, rather

11:13:20 19than the manufacturer of the vehicle.

11:02:10 21 DR. FLETCHER: And summing that up, most

11:13:25 22consumers weren't sure about who establishes tire

11:13:28 23pressures. Most consumers report checking their tires but

11:13:36 25four months. So it's very, very wide range.

11:13:40 1 And consumers acknowledge tire rotation and wheel  
11:13:44 2alignment as being important to the life of their tires,  
11:13:48 3maintenance of their tires, but were not in agreement as  
11:13:51 4to the frequency of how often that should be done.

11:02:09 6 DR. FLETCHER: Some said they did chart their  
11:13:57 7tire maintenance. Others do not, as would be expected.  
11:14:00 8And a few said they got reminders from their dealers where  
11:14:04 9they purchased their tires. Their specific dealer did  
11:14:08 10send out reminders, but that's not a common practice.

11:14:11 11 New car owners were a lot more likely to say they  
11:14:13 12were going to their dealer to get their tire maintenance  
11:14:16 13and rotation done rather than a tire dealer. However,  
11:14:20 14people that were driving used cars more often would go to  
11:14:24 15the tire dealer where they purchased the tires.

11:02:09 17 DR. FLETCHER: Information about tire  
11:14:29 18maintenance, few were familiar with any kind of public  
11:14:32 19information campaign regarding tires or tire maintenance  
11:14:34 20brochures on tire maintenance. Approximately half thought  
11:14:38 21it was necessary to read the owners manual regarding tire  
11:14:41 22maintenance prior to an emergency.

11:02:09 23 --o0o-

11:02:09 24 DR. FLETCHER: As far as knowledge of  
11:14:48 25tire recycling and disposal, the majority said that the

11:14:51 1dealers kept their old tires but they didn't know what the  
11:14:54 2dealers did with the tires when they kept them. They did  
11:14:58 3acknowledge they paid a fee to the dealer to dispose of  
11:15:01 4the tires, but most of them could not remember how much  
11:15:04 5that was.

11:15:04 6 In fact, I think in the Mandarin group there was  
11:15:10 7an argument that ensued. One person said, "No, I said 25  
11:15:12 8cents a tire," and the other guy said, "No, it's a dollar

11:02:09 13 DR. FLETCHER: They were relatively familiar with  
11:15:21 14ways in which tires could be recycled, but they had very  
11:15:25 15little knowledge related to retreaded tires. As a result  
11:15:28 16of that, most of them said they did not trust the quality  
11:15:31 17of retreaded tires and would not even consider purchasing  
11:15:34 18them.

11:15:35 19 Only a few vaguely acknowledged that they thought  
11:15:38 20they remembered something about the California Tire  
11:15:39 21Recycling Act of 1989. But most people know little or

11:15:45 23 And only a few reported the possibility of having  
11:15:48 24seeing a literature review on tire recycling or any kind

11:02:09 2 DR. FLETCHER: Those findings were then utilized

11:16:00 3by us to develop the survey -- the telephone survey that

11:16:03 4you have the text copy you have in the back of the

11:16:07 5handout. It is now being used to collect data in five

11:16:13 6different languages. And we actually pretested the

11:16:17 7English version, found it was too long. And we had to

11:16:20 8actually delete out some of the questions that were not

11:16:22 9central to the objectives. It would have been nice to

11:16:25 10have, but the thing was too long. People were complaining

11:16:28 11about the length. People were hanging up. We shortened

11:16:32 12that down. Pretested it again. It worked fine.

11:16:35 13Pretested it in the other four languages. They're in the

11:16:39 14middle now of collecting that data. We hope at the end of

11:16:40 15the month to have most of all of the data ready to analyze

11:16:43 16and hope to have that for you next month.

11:16:46 17 And with that, I'm open to any questions that you

11:16:49 19 CHAIRPERSON MEDINA: Thank you for your

11:16:50 21 Board members, any questions on this?

11:16:54 22 Board Member Papanian.

11:16:55 23 COMMITTEE MEMBER PAPANIAN: The very last thing

11:16:56 24you said was you're going to have the information --

11:17:00 25 DR. FLETCHER: We're going to have the full

11:17:02 1report on the telephone survey.

11:17:04 2 COMMITTEE MEMBER PAPARIAN: My basic question is

11:17:05 3going to be -- you probably want to answer it next

11:17:08 4month -- what do you think we can do to reach people and

11:17:10 5get them to do some of the preferable practices with their

11:17:16 7 DR. FLETCHER: We're going to have the answers, I

11:17:30 12 COMMITTEE MEMBER PAPARIAN: I look forward to

11:17:32 13hearing that.

11:17:33 14 CHAIRPERSON MEDINA: Board Member Jones.

11:17:35 15 COMMITTEE MEMBER JONES: Was there any linkage

11:17:37 16between tire maintenance and improved fuel economy?

11:17:41 17 DR. FLETCHER: That didn't even come up. That

11:17:43 18was one of the questions, and people sort of, you know,

11:17:48 19said, "Well, if I have my tires inflated properly it

11:17:51 20probably does effect fuel economy." But the real focus --

11:17:54 21and it may be because of all the publicity with the

11:17:57 22Firestone thing, people really focus a lot more on safety.

11:18:02 23That was the primary -- came up over and over and over

11:18:05 24again in the discussion. Fuel economy was not even really

11:18:09 25of concern to many people. It might be more so now

11:18:14 1because fuel prices went up after we did the focus groups.

11:18:17 2It's dependent what's the their issue attention cycle.

11:18:25 3 COMMITTEE MEMBER JONES: I'm worried about the

11:18:25 4amount of tires underinflated. It was like 48 percent or

11:18:29 5something like that.

11:18:31 6 DR. FLETCHER: I know that 9 percent are driving

11:18:33 7with bald tires.

11:18:34 8 COMMITTEE MEMBER JONES: I think it was 48

11:18:34 9percent are underinflated. Irregardless of what kind of

11:18:38 10tire they put on, they're just going to wear it out

11:18:41 11quicker. We've got to figure out how to get that message

11:18:44 12across.

11:18:45 13 DR. FLETCHER: We were recruiting for focus group

11:18:47 14participants and there was a woman we contacted who was

11:18:50 15Russian and had just been in the United States for

11:18:53 1630 days. And this gentleman who is an investigator called

11:18:57 17us to find out if they were legitimate, and began talking

11:18:59 18with him. He's an special investigator for the insurance

11:19:02 19companies. And he said the number one cause of roll over

11:19:05 20accidents is underinflated tires. So he just want -- we

11:19:08 21were calling back for the more in-depth interviews. I

11:19:12 22talked to him for probably an hour and very fascinating.

11:19:17 23And he also was knowledgeable about the statistics on

11:19:20 24underinflated tires being very high.

11:19:22 25 COMMITTEE MEMBER JONES: Just one more question,

11:19:24 1Mr. Chair.

11:19:24 2 Was this inter-agency agreement we led down in

11:19:28 3El Centro?

11:19:31 4 DR. FLETCHER: Yes, it is.

11:19:32 5 COMMITTEE MEMBER JONES: How long did it take you

11:19:33 6to fly out? Because it seems to me you were waiting for

11:19:37 7the winds to die down from about 70 miles an hour to get

11:19:39 8your plane back to Chico.

11:19:41 9 DR. FLETCHER: I went into the airport and all

11:19:43 10around the room were Marine Corp aviators. And I started

11:19:47 11laughing. They started laughing. And they were all there

11:19:50 12for -- until late at night, and I went out early the next

11:19:54 13morning.

11:19:55 14 COMMITTEE MEMBER JONES: Just wondering. Thank

11:19:56 15you.

11:19:56 16 DR. FLETCHER: Thank you very much.

11:19:58 17 CHAIRPERSON MEDINA: Just one question with

11:20:00 18regard to -- you said that in regard to the consumers that

11:20:04 19the dealers -- they're not so much influenced by the

11:20:09 20dealers in regard to the purchase of the tires. But they

11:20:13 21do take brand name into consideration.

11:20:16 22 DR. FLETCHER: They do take brand name into

11:20:18 23consideration. The main point there was the study that

11:20:22 24was done by the tire manufacturers showed that the dealers

11:20:25 25and their representatives had a lot of influence on

11:20:27 1purchase decision. In our phone focus groups we wanted to  
11:20:31 2verify that. We found the tire salesperson has a lot less  
11:20:36 3influence, at least qualitatively in doing this  
11:20:39 4qualitative assessment -- have a lot less influence than  
11:20:40 5the tire manufacturers are saying they have.

11:20:43 6 CHAIRPERSON MEDINA: But the millions that the  
11:20:44 7tire manufacturers put into their marketing campaigns do  
11:20:46 8have some influence on the buying decision?

11:20:49 9 DR. FLETCHER: Well, I think it's more the  
11:20:50 10reputation of the brand. In other words, particularly  
11:20:53 11among minority communities, they talk to their friends and  
11:20:57 12relatives about what kinds of experience they have with a  
11:20:59 13particular brand names. And if they've had a very good  
11:21:02 14experience, they're a lot more prone to buy that brand  
11:21:05 15than they would buy another brand. So I think it's  
11:21:08 16more -- yes, they have ads on TV and they have ads in  
11:21:11 17magazines. But I think that the experience that confirms  
11:21:14 18or denies that information is what's most important and  
11:21:17 19the conveyance of that information by friends and  
11:21:20 20relatives that has the greatest influence on tire purchase  
11:21:24 21decisions.

11:21:24 22 Because particularly in the Mandarin community,  
11:21:27 23the Vietnamese community, and I think the Tagalog and even  
11:21:31 24the Hispanic community, they were saying that we talked to  
11:21:35 25our friends and relatives about the experiences they've

11:21:37 1had with their tires and the dealers they're buying their  
11:21:41 2tires from. And we're a lot more prone to go to those  
11:21:43 3dealers and buy the tires than somebody we don't know  
11:21:47 4anything about.

11:21:50 5 CHAIRPERSON MEDINA: Any other questions or  
11:21:52 6comments, Board members? If not, that will conclude this  
11:21:56 7item. Thank you.

11:21:57 8 DR. FLETCHER: Thank you very much.

11:21:58 9 DEPUTY DIRECTOR LEE: Thank you, Mr. Chairman.

11:22:01 10 Last but certainly not least on the Special Waste  
11:22:03 11Division agenda for morning is Board Item 15, Committee  
11:22:07 12Item I, consideration of concepts funded from the  
11:22:10 13reallocation of unused Fiscal Year 2002/2003 waste tire  
11:22:13 14recycling management program funds.

11:22:16 15 Martha Gildart will make the staff presentation.

11:22:29 16 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART:

11:22:29 17 Good morning, Members. Item 15 deals with our  
11:22:29 18annual reallocation of end-use funds in the tire program.

11:22:29 19 I do want to point out this is the second year of  
11:22:32 20a very ambitious program laid out by the Board's five-year  
11:22:36 21plan for the management of waste tires and that the  
11:22:38 22activities that were carried out in the last year are  
11:22:42 23layered on the first year's activities and have required  
11:22:45 24great efforts on the part of staff to bring this many to  
11:22:48 25fruition.

11:22:49 1 If you want a very brief summary of the moneys  
11:22:52 2remaining, Table 1 on page 15-1 lays out the moneys  
11:23:00 3available in each of the five program elements in the  
11:23:03 4five-year plan. So you can see how those were carried  
11:23:06 5out.

11:23:07 6 In total there is over \$3 million available for  
11:23:10 7reallocation. However, there is \$1,836,000 that must be,  
11:23:19 8if you will, skimmed -- I'm sorry. I've got the tables  
11:23:25 9wrong. That amount is already removed from the total.

11:23:29 10 That is sort of a difficult thing to explain.  
11:23:32 11When the Board adopted the five-year plan two years ago,  
11:23:36 12the funds totaled in that year exceeded the amount  
11:23:43 13actually approved in the state budget as approved last  
11:23:44 14December. So we had to start out from the beginning to  
11:23:49 15save that amount of money. We had to make sure we did not  
11:23:53 16exceed the budget expenditure authority. So --

11:23:56 17 CHAIRPERSON MEDINA: We'll strike the word  
11:23:58 18skimmed from the record.

11:24:01 19 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART:  
11:24:01 20 Yes. I won't say skimmed. It's a fortunate  
11:24:06 21thing, actually, that we were able to account for those  
11:24:09 22dollars. Otherwise, we might have been hurting. So out  
11:24:13 23of the 5.2 million, that 1.8 million has to be removed  
11:24:18 24first, and that leaves the 3.4 million.

11:24:20 25 If you want more details on where all those funds

11:24:24 1came from, Table 2 lists each of the projects in each  
11:24:28 2those five program elements and how they were carried out,  
11:24:31 3what funds were actually encumbered versus allocated and  
11:24:34 4the balance remaining.

11:24:36 5           So on page 15-3, Table 2, if you want we can go  
11:24:42 6down through those different projects and I can explain  
11:24:46 7briefly here and there where the moneys accrued. In some  
11:24:49 8instances a grant program was allocated more money than we  
11:24:52 9actually award. For instance, a local government waste  
11:24:54 10tire enforcement grant which was an increased funding over  
11:24:57 11the first year's 2 million at 4 million this year and 3.7  
11:25:02 12million has been approved by the Board. That leaves the  
11:25:06 13279,527. That holds true for a couple of other grant  
11:25:11 14programs. I won't go into detail there.

11:25:13 15           I will talk briefly under the cleanup, abatement,  
11:25:19 16and remedial action element, the long-term remediation  
11:25:21 17project shows a balance of \$2 million, and that was  
11:25:22 18because the Westley fire site clean up occurred ahead of  
11:25:27 19schedule and under budget. So we were able to remove the  
11:25:30 20\$2 million that had been earmarked for continued work  
11:25:34 21there and make it available for this reallocation.

11:25:39 22           CHAIRPERSON MEDINA: So in regard to the one you  
11:25:41 23used as an example, under enforcement, local government  
11:25:46 24waste tire enforcement grant, the 279,527, you have made a  
11:25:50 25recommendation as to how that should be reallocated.

11:25:56 1 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART:  
11:25:56 2 What we've done, all the excess money from all  
11:25:58 3these different little projects we're proposing to put  
11:26:01 4into one pot. That's what totals the 3.4 million. And  
11:26:05 5then we have separately a listing of possible uses for  
11:26:08 6that 3.4 million, and that is Table 3. And so we don't  
11:26:13 7particularly have the dollars follow, you know, out of one  
11:26:17 8project into another. They go into this pot, and then we  
11:26:20 9pull out of there. Okay.  
11:26:23 10 Let me point out under the clean up and abatement  
11:26:26 11element, the RAC, the rubberized, asphalt, concrete  
11:26:30 12technology center evaluation contract was awarded this  
11:26:34 13year, and we had earmarked \$47,000 from this reallocation  
11:26:40 14effort. So that is shown the parentheses as already being  
11:26:45 15committed. So it's sort of like a negative number so just  
11:26:49 16so you understand how the column on the right works.  
11:26:52 17 The next thing we need to add, because of the  
11:26:55 18action the Committee is recommending today, under the  
11:26:57 19research and promoting alternatives to landfill disposal  
11:27:01 20element, the up-dated report on pyrolysis, gasification,  
11:27:05 21and liquefaction. That one came in under the 150,00 by  
11:27:08 2214,900. So we add to the balance of 50,000, totaling  
11:27:14 2364,900 at that line item.  
11:27:22 24 I'm trying to think if there's anything else.  
11:27:24 25 A couple of the projects we did not have

11:27:27 1sufficient staff resources to assign. The recycled  
11:27:30 2rubberized asphalt concrete is one that did not get  
11:27:34 3undertaken. However, we are working with CalTrans and  
11:27:38 4there are funds being proposed in the revised five-year  
11:27:41 5plan that would include studies of the recycling of  
11:27:44 6rubberized asphalt. We feel we'll be able to take on that  
11:27:47 7issue.

11:27:48 8           The public service announcement, that \$350,000  
11:27:52 9balance that was due to some of the delays in carrying out  
11:27:56 10the contract on the market survey. You just heard the  
11:28:00 11results or preliminary results today. Final results will  
11:28:03 12be presented, we hope, at the June 10th Committee meeting.  
11:28:06 13And from that, we will be able to design a public outreach  
11:28:09 14campaign, but it will be have to be carried out in the  
11:28:14 15next fiscal year. So that \$350,000 is available.

11:28:18 16           The civil engineering uses, this is the same  
11:28:21 17situation that we were in last year. The five-year plan  
11:28:24 18had originally allocated money in both the research  
11:28:27 19element and in the market development element. And we  
11:28:31 20have been able to get interest and support for research  
11:28:33 21projects to demonstrate the use, but we have not yet  
11:28:36 22gotten widespread support on the market development side.  
11:28:40 23People are just a little more cautious in getting into  
11:28:44 24these.

11:28:44 25           What we are proposing in the revised five-year

11:28:47 1plan is to slowly decrease the research effort and try to  
11:28:53 2build the market development effort so it becomes more of  
11:28:53 3a grant program, like the playground grant or RAC grant.  
11:29:00 4That's one of the possibilities for the future. But at  
11:29:00 5this time the \$1 million that had been allocated for the  
11:29:03 6market development side was not expended and is available.

11:29:07 7 As was the signs for the CalTrans project, there  
11:29:11 8was \$30,000 there. We have not been able to work through  
11:29:15 9the CalTrans procedures for approving sign design. We are  
11:29:21 10hoping, once again, in the next year effort to work more  
11:29:25 11with them on that issue.

11:29:28 12 So the total amount of money that the Board has  
11:29:32 13is -- I've got to add that 14,000 in. It should be  
11:29:42 143,438,925,000.

11:29:49 15 CHAIRPERSON MEDINA: Can you repeat that again,  
11:29:51 16please.

11:29:53 17 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART:  
11:29:53 18 3,438,925. Now if you will notice --

11:30:02 19 CHAIRPERSON MEDINA: That would be the bottom  
11:30:03 20line on Table 3?

11:30:05 21 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART:  
11:30:05 22 Yes. The new total -- Table 2. Table 2 at the  
11:30:10 23very top of page 15-4. So the new total is \$3,438,925.

11:30:25 24 We do have an interactive table that shows the listing  
11:30:28 25in Table 3 which is the proposed uses for the remaining

11:30:32 1funds.

11:30:35 2           And if you'll note the total at this point is

11:30:40 3only 2,855,545,000. Obviously we've got somewhere around

11:30:48 4\$500,000 remaining.

11:30:50 5           Just to go down through the projects listed

11:30:51 6there. The first one is the product commercialization

11:30:55 7grants. These are the grants that were approved in

11:30:57 8December. The Board-approved funding. The \$2 million

11:31:01 9allocated but there was additional passing grants for

11:31:06 10which there were no funds available. So we are bringing

11:31:08 11forward here, and the list is included as an attachment.

11:31:14 12And we have prepared a handout describing those projects

11:31:17 13that staff can make available.

11:31:19 14           The next listing is the track and other

11:31:22 15recreational surface grants that was originally allocated

11:31:25 16\$1 million, and there were more passing grant applicants

11:31:29 17than there were funds available. So to make whole those

11:31:32 18additional grants another \$948,000 was required.

11:31:37 19           The LEA training project is one operated by the

11:31:42 20Permitting and Enforcement Division. This is a

11:31:49 21certification program. It did not receive funding with

11:31:53 22the Integrated Waste Management account funds. However,

11:31:56 23the Board had requested back in the September discussion

11:32:00 24that we consider the use of tire funds.

11:32:04 25           If Board members have questions, there is staff

11:32:07 1available from the program to discuss the details of the  
11:32:11 2LEA operator certification program.

11:32:18 3           The next item there is the evaluation of recycled  
11:32:21 4waste tires and playground and track products. This is a  
11:32:25 5proposal we have received from OEHHA. They have presented  
11:32:31 6a scope how they would evaluate the risks posed by the use  
11:32:37 7of the tire rubber and weigh that against the safety  
11:32:37 8improvements from the impact attenuation of the mats.  
11:32:43 9They proposed that at \$300,000.

11:32:45 10           There is a follow-up study proposed for the  
11:32:47 11University -- California State University at Chico to look  
11:32:52 12at the LEVE project that this Board funded and had place  
11:32:57 13about four years ago. That project has been working well.  
11:33:01 14What we want is to have them gather their monitoring data  
11:33:04 15and do an analysis of its performance and the overall  
11:33:09 16cost.

11:33:10 17           The next item is to provide additional funds to  
11:33:17 18the CalMAX waste reduction award program. The five-year  
11:33:19 19plan allocated 200,000 for it. The Waste Prevention and  
11:33:23 20Market Development Division is requesting an additional  
11:33:26 2113,000. The buy recycled conference which I understand is  
11:33:31 22now referred mostly as the buy recycled trade show, Waste  
11:33:35 23Prevention and Market Development Division is asking for  
11:33:37 24additional funding also for that project.

11:33:38 25           Surveillance equipment program, this is one that

11:33:42 1has been proposed by Board members, and staff has  
11:33:47 2investigated entering into an arrangement similar to the  
11:33:50 3Air Resources Board where they're able to provide  
11:33:54 4equipment that can help with surveillance and tracking of  
11:33:59 5waste tire disposal. That's \$100,000.

11:34:03 6           The motion picture industry proposal came about  
11:34:09 7after the Board approved funding in April for contract  
11:34:15 8concept Number 30 at the amount of \$150,000 coming from  
11:34:20 9IWMA end-used oil. However, at that time they also  
11:34:24 10requested that the Special Waste Division consider  
11:34:27 11reallocating tire funds to this contract. So that is  
11:34:30 12shown there.

11:34:31 13           And then lastly, we are proposing an additional  
11:34:36 14\$119,000 to Augment the student contract. This is really  
11:34:39 15of vital importance. As Board Member Jones mentioned  
11:34:43 16earlier, the work that has been done on the manifest  
11:34:48 17program has been tremendous. There is going to be a huge  
11:34:53 18workload in getting this thick out and receiving the  
11:34:55 19manifests back in, processing them adequately. While we  
11:34:58 20do hope to get to an electronic version for as many of the  
11:35:02 21haulers as possible, the first couple years are going to  
11:35:05 22be largely paperwork. And a couple of these students  
11:35:10 23would be directed to that program and some support to  
11:35:12 24other elements of the tire program.

11:35:13 25           So at this point we are available to answer any

11:35:15 1detailed questions and, you know, discuss how some of  
11:35:21 2these could be carried out.

11:35:23 3           If you notice, putting moneys into an existing  
11:35:26 4program such as the grants should be a very simple effort  
11:35:30 5under the state's budgetary time line for the fiscal year.  
11:35:33 6Fiscal year ends June 30th. So by putting moneys into the  
11:35:38 7grant program, we can accomplish that well within that  
11:35:40 8time frame. However, a couple of these will require  
11:35:44 9entering into new inter-agency agreements. There are a  
11:35:49 10couple here that we are trying to bring the scope of work  
11:35:52 11to the Board in June, which -- you know, for the approval.  
11:35:55 12If the board allocates money to, for instance, OEHHA or to  
11:36:01 13the Chico projects, we will be prepared with scopes of  
11:36:04 14work in June for those awards.

11:36:07 15           If any additional contract-type projects are  
11:36:11 16proposed by the Board, we may need to seek delegation of  
11:36:18 17authority to the Executive Director to enter into those  
11:36:21 18agreements as quickly as possible to meet the June 30th  
11:36:25 19time line on the state budget year.

11:36:28 20           So at this point any questions?

11:36:32 21           CHAIRPERSON MEDINA: I'm sure there will be  
11:36:34 22questions. We also have six speakers on this subject so  
11:36:37 23we're going to be calling them up shortly.

11:36:41 24           Board members, do you have any matters you wish  
11:36:46 25to bring up on this?

11:36:48 1 Board Member Paparian.

11:36:49 2 COMMITTEE MEMBER PAPARIAN: If it's all right, I

11:36:50 3do have one specific question on one of the items.

11:36:53 4 I brought this up to the legal staff yesterday,

11:36:55 5and the question is on the product commercialization

11:36:59 6grants, there is one grantee who has already received a

11:37:02 7\$250,000 grant who had a second proposal for \$250,000

11:37:09 8which also scored well and is in the second round. So I

11:37:13 9know that in the information we put out about the grants

11:37:15 10we said that we would disallow projects over \$250,000.

11:37:22 11I'm not quite sure what might have implied about who

11:37:26 12separates projects.

11:37:26 13 I don't know if legal staff is ready to respond

11:37:29 14to that. I just want to clarify. Is it an okay thing

11:37:33 15legally to give two projects under this one item to the

11:37:41 16same entity, or is there an issue?

11:37:45 17 MS. BRECKON: I spoke with the program this

11:37:46 18morning about the projects. In particular, there's one

11:37:50 19entity -- NOFA was written in such a way as to -- as to

11:37:57 20think that one applicant, one business can apply for two

11:38:01 21projects. If you look at the line that says "eligible

11:38:04 22projects, projects that are linked to or part of other

11:38:07 23proposed projects under this grant program" shows that

11:38:10 24staff was thinking about having potentially two projects.

11:38:15 25As long as they're separate projects and not linked

11:38:19 1together, that would be okay to fund.

11:38:20 2 Martha had a something that she wanted to say

11:38:26 3about this as well.

11:38:28 4 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART: I

11:38:28 5just wanted to point out that we have in past years also

11:38:31 6funded applications that came from the same business

11:38:35 7entity for two separate activities, two separate projects

11:38:40 8as long as they're not dependant upon one another. And if

11:38:44 9you'd like more detail on the specifics of these projects,

11:38:48 10we'd be happy to provide that.

11:38:50 11 COMMITTEE MEMBER PAPARIAN: No. My question was

11:38:50 12basically whether we have a legal problem. And if we

11:38:54 13don't have a legal problem on this one, I'm satisfied. I

11:38:58 14would like to flag it the next time we come up so the

11:39:01 15Committee can discuss whether they want to continue that

11:39:05 16practice or not. But in terms of this one, if it's legal

11:39:07 17to do it this way, that's fine with me.

11:39:10 18 CHAIRPERSON MEDINA: Before we proceed let me

11:39:12 19just ask in regard to Table 3, these are the

11:39:15 20recommendations that staff is making in regard to the

11:39:18 21reallocation. Are there any corrections, any changes to

11:39:25 22Table 3.

11:39:26 23 DEPUTY DIRECTOR LEE: Not at this point,

11:39:27 24Mr. Chairman. As I mentioned in my opening remarks,

11:39:30 25though, we have received -- I believe the Board -- the

11:39:33 1Committee has also received a memorandum from the Board  
11:39:36 2Chair which basically lists some additional projects for  
11:39:39 3reconsideration as part of the reallocation.  
11:39:41 4 Staff hasn't had a chance to really review these  
11:39:44 5in-depth. We think the concepts have significant merit,  
11:39:50 6but we prefer to have a couple extra days to kind of look  
11:39:55 7at these and perhaps resolve the issue at the Board  
11:39:57 8meeting.  
11:39:59 9 Staff would like to receive any comments that the  
11:40:02 10Committee members might have, and that would help us with  
11:40:05 11our work in trying to decide how we're going to be working  
11:40:13 12with these particular concepts.  
11:40:15 13 CHAIRPERSON MEDINA: Okay. Let me get some  
11:40:18 14feedback in regard to that.  
11:40:19 15 Board Member Jones.  
11:40:20 16 COMMITTEE MEMBER JONES: Thank you, Mr. Chairman.  
11:40:22 17 I have just a couple of questions. The OEHHA, we  
11:40:28 18couldn't fund -- OEHHA came to us with two proposals. One  
11:40:32 19to do the track. And one to do the fuel as a supplement  
11:40:37 20back when we were doing the -- one of the workshops for  
11:40:41 21the five-year plan. I just don't remember what the  
11:40:44 22supplement part of that was. We adopted the running track  
11:40:50 23one, you know -- or the mold and rubber product one,  
11:40:56 24wasn't that went to OEHHA for 3-?  
11:41:00 25 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART:

11:41:00 1 If I remember --

11:41:02 2 COMMITTEE MEMBER JONES: Or was that Emergency

11:41:03 3Response?

11:41:05 4 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART:

11:41:05 5 Yeah. There was emergency response for the

11:41:07 6responders to fires.

11:41:11 7 COMMITTEE MEMBER JONES: We did that one. What

11:41:12 8was the other one?

11:41:14 9 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART:

11:41:14 10 And then down the road there was -- there's been

11:41:16 11three. It's been a combination of meetings between the

11:41:20 12Board staff and OEHHA. There are actually three projects

11:41:24 13that could be eventually done by OEHHA. We felt this

11:41:27 14playground track -- one could be done first as the Board

11:41:31 15has put so much time and effort into promoting the tracks.

11:41:34 16The tire response was one that came out of their report

11:41:38 17that was required by the Legislature on the effects of

11:41:41 18fire. There is down the road in the five-year plan

11:41:44 19funding for water quality effects of civil engineering

11:41:50 20tires chips.

11:41:50 21 COMMITTEE MEMBER JONES: Okay.

11:41:52 22 CHAIRPERSON MEDINA: So in regard to the

11:41:52 23evaluation -- in regard to the 300,000 that's indicated in

11:41:58 24Table 3 for OEHHA, 100,000 would be taken out of that

11:42:05 25and --

11:42:09 1 DEPUTY DIRECTOR LEE: That is the current  
11:42:10 2proposal by the Board Chair. Like I said, staff would  
11:42:14 3like to kind of look at that situation. We have some  
11:42:17 4qualms about OEHHA's ability to implement the entire scope  
11:42:23 5of that fuel supplement study. But otherwise, that's our  
11:42:29 6major concern.

11:42:33 7 CHAIRPERSON MEDINA: So the 100,000 that would be  
11:42:35 8taken out of that would be used for what?

11:42:38 9 SUPERVISING WASTE MANAGEMENT ENGINEER GILDART:  
11:42:38 10 As we understood it, back during discussions of  
11:42:41 11five-year plan staff had proposed to do a contract to  
11:42:48 12update the 1992 Board report, tire as a fuel supplement.  
11:42:49 13That was a requirement of the original Assembly Bill 1843  
11:42:54 14language that created the Tire Recycling Act. And that  
11:42:56 15was a report done by Board staff, and it was a very  
11:42:59 16highly-regarded report because not only did it look at the  
11:43:02 17use of tires as a fuel, it looked at other methods of  
11:43:06 18diverting tires from landfill disposal, did a comparison  
11:43:10 19on some of the costs and viability. It included emissions  
11:43:14 20data from various facilities, risk assessments.

11:43:17 21 As I understand it, the proposal now from the  
11:43:20 22Chair's office is that OEHHA could be involved in that.  
11:43:23 23We need to consult with OEHHA to see what aspects of that  
11:43:28 24report they feel they could handle and whether they would  
11:43:30 25have to then subcontract or in some other way perform the

11:43:35 1 other portions of that report.

11:43:37 2 CHAIRPERSON MEDINA: Okay. Well, all of these  
11:43:38 3 items will go to them for vote by the full Board anyway as  
11:43:44 4 fiscal consent. So at this point why don't we take it up  
11:43:52 5 before the full Board since it's going to go up to the  
11:43:55 6 full Board for fiscal consent. That gives you time to  
11:44:00 7 work in the Chair recommendations which I haven't had a  
11:44:03 8 chance to review and apply to what's in Table 3. We do  
11:44:10 9 have six speakers.

11:44:13 10 Board Member Washington.

11:44:15 11 COMMITTEE MEMBER WASHINGTON: Martha, in terms of  
11:44:16 12 the track and other recreational surface grants in the  
11:44:21 13 application that are before us from the San Mateo High  
11:44:25 14 School --

11:44:28 15 SECRETARY HARRIS: I don't think she's seen them.

11:44:31 16 COMMITTEE MEMBER WASHINGTON: Oh, these are  
11:44:32 17 something new then you haven't seen.

11:44:34 18 DEPUTY DIRECTOR LEE: We were aware -- we  
11:44:35 19 received some -- we had some telephone conversations with  
11:44:38 20 that particular grant applicant.

11:44:40 21 COMMITTEE MEMBER WASHINGTON: What about the City  
11:44:41 22 of Oakland? And the city -- and the Ceres Unified School  
11:44:48 23 District?

11:44:49 24 SUPERVISING WASTE MANAGEMENT ENGINEER Gildart: I  
11:44:50 25 haven't seen any additional material above and beyond what

11:44:53 1 was submitted in the original grant application that was  
11:44:55 2 reviewed and approved by, you know, staff. If they've  
11:45:03 3 sent us additional information, I have not seen it.  
11:45:05 4 CHAIRPERSON MEDINA: Okay. In light of the  
11:45:05 5 additional materials and the memo from the Chair, I'll  
11:45:11 6 move this item to the full Board so that we can have a  
11:45:15 7 more complete discussion.  
11:45:16 8 What I would like to do because there are  
11:45:18 9 speakers here, and I do hope to adjourn by 12:00. And so  
11:45:22 10 I would like at this moment to call the speakers up  
11:45:27 11 beginning with Jim Ryugo. If you would come them and keep  
11:45:32 12 your remarks brief. I'll set the timer for three minutes  
11:45:37 13 only because there is no two-minute on the timer.  
11:45:40 14 (Laughter)  
11:45:42 15 MR. RYUGO: Good morning. My name is Jim Ryugo  
11:45:43 16 with the City of Oakland, Office of Parks and Recreation.  
11:45:46 17 We submitted a grant application for  
11:45:48 18 consideration for a San Antonio Park. I just want to  
11:45:51 19 highlight the importance of this grant application for us.  
11:45:54 20 San Antonio neighborhood is one of the highest  
11:45:56 21 density populated areas in the City of Oakland. We have a  
11:46:01 22 planning goal of four acres of open space per 1,000  
11:46:06 23 residents. In the San Antonio district there's .78 acres  
11:46:10 24 of open space, and that translates that less than 34  
11:46:14 25 square feet per person. When you think about it, a sheet

11:46:16 1of plywood is 32 square feet so we're definitely deficient  
11:46:20 2in open space in this area.

11:46:21 3 The population's young and rapidly expanding.

11:46:25 437 percent of the population is under age 18; 47 percent

11:46:32 5unemployed; 44 percent of the children live below the

11:46:37 6poverty line. The medium income in the neighborhood is

11:46:40 7\$28,432. There is clearly a need for economic development

11:46:46 8in the area. But the park is one of the key places where

11:46:49 9people can recreate, relax, enjoy.

11:46:55 10 If you look in your packet, there is a number of

11:46:58 11letters of endorsements. If you turn to the last page

11:47:01 12there is a photograph that shows what the field looks

11:47:05 13like. In the wintertime it's a muddy problem for us. In

11:47:08 14the summertime it's a real dusty unplayable situation.

11:47:14 15But the kids don't have any alternatives, so that's where

11:47:17 16they play soccer.

11:47:19 17 Our vision for the field is converted into a

11:47:21 18small multi-purpose field approximately 120 feet by 250

11:47:27 19feet using the recycled ground rubber as a surfacing.

11:47:31 20 CHAIRPERSON MEDINA: You're here in support of

11:47:33 21funding for this project?

11:47:35 22 MR. RYUGO: That's correct.

11:47:35 23 CHAIRPERSON MEDINA: Thank you. We have the

11:47:36 24materials. We'll give them full consideration.

11:47:39 25 COMMITTEE MEMBER WASHINGTON: Mr. Chair, I'd like

11:47:40 1to add I think it's a great opportunity to put some  
11:47:44 2resources. I've been in that area several times, and that  
11:47:48 3certainly is a park that is in dier need of support. And  
11:47:51 4this is a good opportunity for this Board to help out the  
11:47:55 5City of Oakland in that area.

11:47:58 6 MR. RYUGO: I appreciate your consideration.

11:48:00 7 CHAIRPERSON MEDINA: I am very familiar with the  
11:48:01 8park.

11:48:02 9 Board Member Jones.

11:48:04 10 COMMITTEE MEMBER JONES: Quick question. Did you  
11:48:05 11apply for a grant?

11:48:06 12 MR. RYUGO: We're on the B list instead of the A  
11:48:09 13list.

11:48:09 14 COMMITTEE MEMBER JONES: You're on the B list.

11:48:10 15And the other ones that are coming up, if you could tell  
11:48:10 16us if you're on the B list or not, it makes a difference.

11:48:14 17 COMMITTEE MEMBER WASHINGTON: Or no list.

11:48:17 18 COMMITTEE MEMBER JONES: Yeah. Anybody that's on  
11:48:18 19no list ain't going to be on my list.

11:48:24 20 (Laughter)

11:48:25 21 CHAIRPERSON MEDINA: The next speaker is Patrick  
11:48:27 22Winters, followed by Steven Cryger and Mark Greenough.

11:48:32 23 So if you're here speaking in support of your  
11:48:35 24project, please let us know that you strongly support this  
11:48:38 25project. It has merits. And if you have materials in to

11:48:41 1us, we'll review those materials. And if not, get those  
11:48:45 2materials in to us. Thank you.

11:48:49 3 MR. WINTERS: Still good morning. We're on the A  
11:48:52 4list for that. We are Hunter Paine, and we're here to  
11:48:57 5tell you a little bit about our company. We have three  
11:48:59 6minutes to do that. We're a G4 in our mind, which is we  
11:49:03 7are a green to the fourth power to do that. Three of our  
11:49:07 8core products -- if you'll look to the back, you can see  
11:49:10 9some pallets back here. We make a pallet composite wood  
11:49:14 10material. Since we use -- we are actually here to  
11:49:20 11preserve the forest as we move along. And our product  
11:49:25 12shelf life -- at the end of the shelf life, we're able to  
11:49:29 13take our product and regrind it back into the system.  
11:49:31 14We're fully reusing the products as we move along.

11:49:34 15 We're a clean business in which we have no VOC's.  
11:49:38 16All the operations that we're proposing here to put our  
11:49:41 17business in the state of California -- this is from  
11:49:44 18actually producing lexsite which is composite material to  
11:49:48 19the finished product are all intertwined. We can do this.  
11:49:51 20It's an industry we can put together that fully integrates  
11:49:56 21all the way through. We're sanitary, which is something  
11:50:00 22that should be of interest. And I thank you for  
11:50:05 23listening. Hunter Paine.

11:50:05 24 CHAIRPERSON MEDINA: Next speaker.

11:50:08 25 MR. CRYGER: Good morning. Thank you for giving

11:50:10 1us the opportunity to talk to you today a little bit about  
11:50:13 2the San Mateo High School Centennial Stadium project, in  
11:50:14 3particular our track. My name is Steven Cryger. I'm the  
11:50:17 4athletic director and mathematic teacher at San Mateo  
11:50:21 5High. With me is Mark Greenough who is an alumni of the  
11:50:23 6school, businessman in our community, as well as the head  
11:50:26 7track and field coach, and a member of our fund-raising  
11:50:29 8committee.

11:50:30 9 We currently have undertaken redesigning our  
11:50:33 10whole stadium. The stadium itself is 60 years old. We've  
11:50:36 11had to replace all the wood in the bleachers in the last  
11:50:40 12two years because it's all rotted. The field is very  
11:50:43 13hard, doesn't drain well. And the track in particular is  
11:50:45 14all dirt and granite, has potholes is very uneven. The  
11:50:50 15curbing in at least 30 sections has broken apart and has  
11:50:53 16exposed rebar. We've sustained a number of injuries over  
11:50:57 17the years due to the poor condition of our track.

11:51:01 18 We are currently in the process of a joint use  
11:51:04 19project with both the City of San Mateo and the school  
11:51:07 20district to redo that whole stadium. At San Mateo High  
11:51:11 21School we are a community school. We've already opened a  
11:51:14 22community gymnasium. We have a performing arts center, a  
11:51:19 23adult center on our campus. So the community is using our  
11:51:22 24facilities on a regular basis. We feel it's our  
11:51:25 25responsibility to provide a safe environment not only for

11:51:27 1 our students but for the community as well.

11:51:30 2 We have already submitted a grant proposal. It

11:51:34 3 will receive a passing score so we are on that B list. We

11:51:36 4 did prepare a Power Point presentation. You have the

11:51:40 5 package the front of you which details the complete

11:51:43 6 project, letters of support from Commissioners of the

11:51:47 7 Central Coast Section, Peninsula Athletic League, the head

11:51:51 8 of the Department and Regs, our superintendent, also

11:51:55 9 detailing the condition of the track by the head of our

11:52:00 10 Department of Maintenance.

11:52:01 11 So we urge you to support our project. Certainly

11:52:05 12 we have a lot of the funding in place, but this would be a

11:52:08 13 key component to be able to complete that project. Thank

11:52:13 14 you very much.

11:52:14 15 CHAIRPERSON MEDINA: Okay. Thank you for your

11:52:16 16 presentation.

11:52:16 17 COMMITTEE MEMBER WASHINGTON: Mr. Chair, can I

11:52:19 18 chime in real quickly and say that San Mateo High School

11:52:20 19 is another high school I had an opportunity to go visit

11:52:25 20 and speak at with the former assemblyman who took me down

11:52:26 21 there to see some of the young people there. And again,

11:52:30 22 he's absolutely correct that there needs to be some --

11:52:33 23 this is another situation that I think certainly is well

11:52:37 24 deserving of resources, that we can make it possible for
