1. Why does your jurisdiction need more time to meet the 50% goal? Describe why SRRE selected programs did not achieve 50% diversion. Identify barriers to meeting the 50% goal and briefly indicate how they will be overcome.

The programs included in the time extension are either new programs or expansions of existing programs. In either case time is needed for the programs to be implemented and incorporated to achieve the projected diversion tons.

The SRRE selected programs did not previously achieve 50 percent diversion because the programs were not designed to be aggressive enough to capture enough diversion tons.

The programs listed in the first time extension were not able to achieve the 50 percent goal. One reason the first time extension was not effective was because the program projected to capture the most waste, the Material Recovery Facility (MRF), was not constructed. The City was unable to find land within City limits to build the MRF. The City is continuing to look for alternative sites for construction of this facility but it is not included as a program in this application.

Another reason the first time extension did not achieve the 50 percent goal is because the expansion of the green waste program was not implemented. It was not expanded because the City experienced budget restrictions and was not able to follow through with the greenwaste program. The City Council has already approved a garbage rate increase to cover the program costs for this time extension.

The biosolids program listed in the first time extension was implemented and it diverted 1,079 tons in 2002.

The curbside green waste is currently picked up monthly. The City plans to expand this program to a bi-weekly pick-up. The goal is for the hauler to move to an automated system and provide the customers with green waste bins.

At this point in time the City does not have a C&D ordinance in place. In the time extension programs the City plans to draft and adopt a C&D ordinance. The City currently has a sorting program at the yard, the C&D ordinance will expand this program.

The City Council has voted to direct the staff to bring a C&D ordinance and a mandatory recycling ordinance for their consideration. The City has a curbside source-separated recycling program.

The barriers for the City to achieve 50 percent diversion are low program participation and insufficient funding for programs.

The City understands the answer to the diversion problem is through the people. The City plans to increase its public education efforts to increase public awareness and participation in all programs. The City's website will be updated on a quarterly basis. All new programs will be implemented with educational information provided to the residents and the commercial businesses.

In response to the second barrier, the City is trying to obtain expired grant money for another avenue to fund new or expanded programs. On July 12th 2004, City Council approved a garbage rate increase to provide more funding for planned programs.

2. Why does your jurisdiction need the amount of time requested? Describe any relevant circumstances in the jurisdiction that contribute to the need for a Time Extension.

The time requested will be needed for all programs to be fully implemented and incorporated into the jurisdiction. The public education efforts need to be absorbed and reiterated to become effective in conjunction with the programs.

There are some specific programs the City will focus at the beginning of the time extension period. These programs include the City's procurement policy, the C&D ordinance, recycling containers at the service stations and beaches, waste audits for both schools and large businesses, and the mandatory recycling ordinance.

The green waste pilot program will take priority during the first months of the extension. After the pilot program is completed, it will take time to assess and evaluate the program in order to establish the permanent curbside green waste program.

Other programs, for example, the 2005 Waste Generation Study, will occur at the end of the extension period in 2006.

The City has carefully planned the programs and ensuing timelines for each program in the time extension period. Because of the number of programs being addressed, the total time estimated in the extension will be needed.

3. Describe your jurisdiction's Good Faith Efforts to implement the programs in its SRRE.

Attached are the PARIS forms describing the City's efforts. In addition to these efforts, the City has focused efforts on the following areas.

1. The City made special request and continues to seek expired DOR grant money to implement recycling bins on the beaches and other public areas in an effort to keep the City litter free and divert tourist garbage from the City's waste stream.
2. The hauler Coastside Scavenger Company (CSC) sends an annual survey to all customers in an effort to highlight services that need attention or address any issues or concerns the customers may have.
3. The City's residents are very environmentally conscious, there is an Environmental Family/Beach Coalition that meets periodically for beach restoration and clean up efforts.
4. The City promotes self-pride to residents by running advertisements in each addition of the weekly newspaper encouraging residents to 'Keep Pacifica Scenic — Don't Litter'.
5. At the City's annual Fog Festival, the hauler separates all recyclables from the waste by hand to capture as much material as possible. On site containers to source separate the materials were found to be ineffective.
6. CSC attempts to capture all recyclable material from the waste by handpicking materials from the wastestream during regular pick-up routes.

The City recognizes its current efforts have not been enough to reach the State's diversion goal of 50 percent. However we expect the new programs and expanded programs proposed in the time extension will significantly increase the diversion from the residential and commercial sectors.

The City council has already approved a garbage rate increase to provide some funding for the proposed programs.
