NOTICE

TO: All Interested Parties

Subject: Periodic Review of Convenience Zone for Exemption

This notice is an advisory of the upcoming review of convenience zones by the Department of Resources Recycling and Recovery, Division of Recycling (Division). Public Resources Code Section 14571 (a) requires that a certified recycling center be located within every convenience zone in California. A convenience zone is the area within a half-mile radius around every supermarket that grosses \$2 million or more in annual sales. The Division may grant an exemption from the requirement to establish a recycling center in a convenience zone, if specific mandated conditions are met.

The Division periodically reviews convenience zones to determine if conditions warrant granting an exemption. Demographic and physical issues may vary widely from one convenience zone to the next. Therefore, each zone is evaluated on a case-by-case basis. At the conclusion of this review, the Division will notify you in writing of the decision.

The Division encourages you to provide written testimony in support of, or in opposition to, the exemption of any of the zones listed on the report (Attachment A) for this exemption review cycle. Testimony will be accepted through close of business on **August 23, 2010**. You may submit testimony electronically by e-mailing Walt Simmons at: walt.simmons@conservation.ca.gov.
