Subject: **Plastic Trash Bag Annual Certification for Calendar Year 2011**

The Department of Resources Recycling and Recovery (CalRecycle) has identified your company to be a wholesaler selling regulated plastic trash bags of .75 mil or greater in thickness within California. Plastic trash bag wholesalers are required to submit an annual certification that represents the previous calendar year's (January 1st – December 31st) activities. The annual certification is based on the compiled and maintained records regarding the shipping locations and supplier information (California Public Resources Code Sections 42290-42298 and Title 14 California Code of Regulations (CCR) Sections 17975-17985).

Annual Certification Requirements:

Please file your 2011 certification using the Plastic Trash Bag Manufacturer Certification Form (Form 57) available at www.Calrecycle.ca.gov/buyrecycled/trashbags **no later than March 1, 2012**. Wholesalers submitting late forms will not have another chance to come into compliance until the 2012 certification reporting period.

Note that to be compliant with the program you must complete all applicable sections, sign and submit the certification form whether or not you sold regulated plastic trash bags in California during 2011.

Public Records Act and the Information Practices Act:

CalRecycle is subject to the provisions of the Public Records Act and the Information Practices Act (14 CCR Sections 17041-17046 (www.Calrecycle.ca.gov/Laws/Regulations/title14/ch1.htm#ch1a4)). If you believe that some or all of the information that you are submitting is confidential, proprietary or a trade secret, you must identify in writing, the information that you believe should be maintained as confidential.

In addition, you must provide the name, address, and telephone number of an individual to be contacted if CalRecycle receives a request for disclosure of or seeks to disclose confidential information. The regulations noted above provide more details on the process to be followed and criteria to be used if there is a request for confidential information, and those requirements provide you with an opportunity to explain why the information should remain confidential in the event a request is made.


Non-Compliance:

If CalRecycle determines your company to be non-compliant with any of the requirements of the Plastic Trash Bag Law, your company will be prohibited from entering into any contract, or amending or renewing an existing contract with the State of California for the provision of any product or service. Your company will remain ineligible until after it has submitted a timely, complete, and accurate certification to CalRecycle for the 2012 compliance year.

If your company does not meet the definition of a wholesaler, does not sell regulated plastic trash bags or can liners in California, or you feel you received this letter in error, please notify CalRecycle's Plastic Trash Bag Program staff immediately.
