8 calendar.



10 **ADMINISTRATIVE DECISION BASED UPON ADOPTION OF STIPULATION FOR**
11 **ISSUANCE OF ADMINISTRATIVE DECISION**

12 I hereby adopt the Stipulation for Issuance of Administrative Decision,
13 and the Amended Stipulation for Issuance of Administrative Decision, and good cause
14 appearing therefore, the following Order is hereby made:

15 (A) Respondent DONALD SEARCY, INDIVIDUALLY AND AS PRESIDENT AND
16 CEO OF STR ENTERPRISES, AND STR ENTERPRISES, INC., Operator shall pay a
17 monetary penalty of Seventeen Thousand Five Hundred Dollars, (\$17,500.00) to
18 Complainant, the California Integrated Waste Management Board.

19 (B) THE VAN DEN ABELEN FAMILY TRUST, DATED NOVEMBER 19, 1996
20 (CHALRES VAN DEN ABELEN AND CYNTHIA VAN DEN ABELEN, AS CO-
21 TRUSTEES), Owner shall pay a monetary penalty of Five Hundred Dollars (\$500.00) to
22 Complainant, the California Integrated Waste Management Board.
