The LEA shall indicate whether each hearing panel was appointed pursuant to PRC 44308(a)(1), Governing Body as the Hearing Panel, or PRC 44308(a)(2), Independent Hearing Panel or Hearing Officer. The LEA shall include the address to which filings and correspondence shall be mailed. (The mailing address can be the LEA Director/Office/Address).
