



History

- Aka Long Beach dump #20 and 26
Long Beach City Dump Landfill
- Disposal area – 17.4 acres
- Depth of fill – 4.5 ft – 30 ft
- Types of Wastes – Residential, Commercial, Industrial
- Dates of Operation – 1942 – 1948
- Final Cover – 2 to 4 feet
- Total Tonnage – approximately 43,600 tons

- 55th Way Landfill – Community Park Redevelopment money
- 4 My Storage – Private owner Sunbelt Company
- Friendly Village Mobile Home Park
- Cal Coast Packing Co.



THE BAD

- NO LEAD AGENCY AT START OF PROJECT
- NO STATE CLEARINGHOUSE
- NO APPROVED LINER OR PASSIVE VENT SYSTEM.
- DURING EXCAVATION NO COMPLIANCE WITH AIR BOARD ISSUED EXCAVATION PERMIT



DIFFICULTIES

- LOCAL CITY DETERMINED PROJECT TO BE MINISTERIAL, THEREFORE NO CEQA REQUIRED BY THEM
- CITY ISSUES BUILDING & GRADING PERMITS
- LEA REVIEWS PROJECT AND DETERMINES MAJOR IMPACTS TO THE ENVIRONMENT AND THE HEALTH AND SAFETY OF THE PUBLIC.
- Determination results IN SHIFT IN LEAD AGENCY FROM LOCAL CITY TO LEA
- WHO DOES THE CEQA?
- COMMUNICATION BETWEEN AGENCIES
- ON-GOING PROJECT HAS HAD 3 DIFFERENT CONSULTANTS

CONDITONS REQUIRED BY LEAD AGENCY

- Required the developer to take steps to notice the public of the project
- several community meetings scheduled
- Excavation Permit from AQMD
- Approval from County Public Works for proposed liner and gas monitoring system
- SOIL GAS BORING
- Submittal of a comprehensive work plan

PROJECT HISTORY

- INITIAL PROJECT INVOLVED DEVELOPING OVER FILL
- 1ST CHANGE INVOLVED EXCAVATING OUT REFUSE AND DEEMING SITE AS CLEAN CLOSED
- 2ND CHANGE INVOLVED PARTIAL EXCAVATION AND PARTIAL DEVELOPMENT OVER FILL
