The County of San Diego, Department of Environmental Health Solid Waste Local Enforcement Agency (LEA) received a Solid Waste Facility Permit (SWFP) application package, submitted in duplicate, for a new Solid Waste Facilities Permit (SWFP) on January 22, 2010 for SANCO Recycling. SANCO Recycling is an existing materials recovery facility and processes commingled source separated recycling materials. SANCO Recycling is currently operating under a temporary solid waste facility permit which is set to expire on June 30, 2010.

On February 18, 2010, the LEA found the application to be complete and correct and accepted the application package for filing. A public informational meeting has been scheduled for March 9, 2010. Enclosed is a copy of the Meeting Notice.

Please be advised that the County of San Diego Department of Environmental Health, Solid Waste Local Enforcement Agency (LEA) will be holding an informational public meeting in compliance with Public Resource Code §44004(h) regarding a new proposed Solid Waste Facility Permit for SANCO Recycling, SWIS #37-AA-0965. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle), formally known as the California Integrated Waste Management Board, to enforce state laws and regulations at solid waste facilities.

SANCO Recycling is an existing materials recovery facility with a processing and storage area of 49,205 square feet located at 1044 W. Washington Ave, Escondido, CA. On January 22, 2010 the LEA accepted for review a full Solid Waste Facility Permit (SWFP) application package from SANCO Services to allow its continued operation of SANCO Recycling. SANCO Recycling is operating under a temporary SWFP that expires on June 30, 2010.

A new full SANCO Recycling SWFP #37-AA-0965 would:

- Replace the temporary solid waste facility permit issued to SANCO Recycling resulting from new state regulations (AB 1473);
- Allow SANCO Recycling to continue to operate as a Materials Recovery Facility (MRF);
- Allow the continued receipt of 723 tons per day of commingled/source separated recyclable material; and
- Allow the continued days and hours of operation, Sunday - Saturday, 24 hours per day.

The LEA's preliminary determination is to approve the new proposed Solid Waste Facility Permit. The new proposed SWFP will not allow for the facility to receive municipal solid wastes for processing.

This Public Meeting is for any interested parties to learn more about the new proposed SWFP and to provide comments to the LEA regarding the proposed action. The decision to approve or deny a new SWFP will be made by the LEA within 120 days of the date the application was deemed complete as required by State statute, and will be submitted to the California Department of Resources Recycling and Recovery (CalRecycle) for concurrence.

Copies of the proposed new SWFP and application package for SANCO Recycling are available for public review in the LEA office located at 9325 Hazard Way, San Diego, CA 92123-1217.
