Please be advised that the County of San Diego Department of Environmental Health Solid Waste Local Enforcement Agency received and accepted an application from SANCO Services for a Report of Facility Information (RFI) amendment associated with the operation of SANCO Resources Recovery in Lemon Grove, CA. The LEA is certified by California Department of Resource Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste facilities within the County of San Diego.

Description of Proposed Changes: The application package is to amend RFI items identified during a routine Five Year Permit Review, including the following: a new bag house system for dust control; clarification of current vs. future processing equipment; updates to emergency contacts; floor plans; residuals quantities; and equipment lists.

LEA Findings per §21665(c): The County of San Diego Solid Waste Local Enforcement Agency finds the proposed changes are consistent with California Environmental Quality Act documents; the proposed changes are consistent with State Minimum Standards; and the proposed changes do not conflict with the existing Solid Waste Facility Permit (SWFP).
