Dear Mr. Hunter:

California Integrated Waste Management Board (CIWMB) staff, acting as the Enforcement Agency (EA) pursuant to PRC 43202, received your letter in regards to the proposed solid waste facilities permit (SWFP) for the Sunshine Canyon City/County Landfill (Landfill).

Your letter cites a March 1, 2008 letter from the North Valley Coalition (NVC) and comments from the City of Los Angeles, Community Advisory Committee Sunshine Canyon Landfill. I have searched our records and have not located a NVC letter dated March 1, 2008. Additionally, your letter does not state what specific letters and/or comments the Granada Hills North Neighborhood Council and the City of Los Angeles, Community Advisory Committee Sunshine Canyon Landfill has provided.

During the Informational Meeting held in regards to the submitted SWFP application for the Landfill on March 25, 2008, comments were received and the CIWMB response to comments can be located at:
