ADMINISTRATIVE DECISION

The California Integrated Waste Management Board ("CIWMB") served an Administrative Complaint and Request for Hearing form on EDDIE L. WILLIAMS ("RESPONDENT") on January 28, 2005, giving RESPONDENT 15 (fifteen) days from the date of service to file the Request for Hearing. RESPONDENT did not file a Request for Hearing. The matter shall be determined as a default pursuant to Public Resources Code 42851(b) and Government Code section 11520. The CIWMB takes action against the RESPONDENT based upon evidence and affidavits that may be used without any notice to the RESPONDENT.

FACTUAL FINDINGS

1. The Administrative Complaint was executed by WENDY BRECKON, Staff Counsel, CIWMB, acting in her official capacity.
2. RESPONDENT is responsible for the transporting of used or waste

1 tires by an individual not holding a Waste Tire Hauler Registration.

2 3. On August 28, 2001, RESPONDENT became registered as a Waste
3 Tire Hauler with the CIWMB. This initial registration expired on December 31, 2001
4 and was not renewed.


5 4. On December 14, 2004, KEITH E. CAMBRIDGE, Program Manager of
6 the CIWMB Waste Tire Hauler Registration & Manifest Program conducted an
7 investigation of which showed that RESPONDENT continued to haul waste or used
8 tires during the 2003 and 2004 calendar year without being a current CIWMB
9 Registered Waste Tire Hauler.

10 **ORDER**

11 Pursuant to Public Resources Code section 42962 and Government Code
12 section 11520, THE FOLLOWING ORDER is hereby made:

13 RESPONDENT, EDDIE L. WILLIAMS is ordered to pay an administrative
14 penalty of \$2,000.00 (two thousand dollars) to the California Integrated Waste
15 Management Board within 30 (thirty) days of the date of this decision.

16 This DECISION shall become effective February 28, 2005.
