**ADMINISTRATIVE DECISION PURSUANT TO STIPULATION**

Pursuant to that certain "Stipulation for Issuance of Administrative Decision" dated  
December 13, 2005, entered into by and between Complainant CALIFORNIA INTEGRATED  
WASTE MANAGEMENT BOARD (the "CIWMB"), on the one hand, and Respondents Joe P.  
Di Redo, Rose Marie Di Redo, Dan Cetrone, Lucretia Cetrone, Virginia Fornasir, Mary  
Blackhart, and the Di Redo Family Trust (hereafter collectively "Respondents"), on the other

1 hand, and good cause appearing therefore, the following Administrative Decision is hereby  
2 issued in this proceeding:

3 Respondents shall pay a monetary penalty of Thirteen Thousand, Five Hundred Dollars  
4 (\$13,500.00) to Complainant the California Integrated Waste Management Board. Said  
5 Respondents shall pay interest at the legal rate, plus reasonable attorney's fees and other costs of  
6 collection, commencing on the date the CIWMB converts this Decision into a Judgment.
