

**EXPLANATION OF CHANGES TO THE PROPOSED REVISIONS TO THE
RIGID PLASTIC PACKAGING CONTAINER REGULATIONS –
SECOND 15-DAY VERSION**

Subsequent to the first 15-day public comment period, CalRecycle made a number of changes to the regulations for consistency and clarity; the Office of Administrative Law (OAL) also identified three (3) changes. *Shaded italics* represent the second 15-day revisions capturing final clean-up edits made to insert inadvertently lost words, letters or punctuation from the existing text, and lost underlines or strikeouts from edits shown in prior versions; and additional clean-up edits made for consistent phrasing, format and punctuation.

The supporting explanation for the changes made:

17942

Added back in the “Authority” and “Reference” citations previously noted for deletion as these will remain in the Code of Regulations.

17943 (k)

Added in section “17945.5” as that replaced existing section 17946.5 but was inadvertently left out.

17943 (o)

Changed term “Sections” to “Section” for consistent phrasing throughout the regulations.

17943 (p)

Added in word “is” from current text intended to be deleted but inadvertently left out of draft.

17943 (w)(1)

Added in missing phrase “that a” from current text intended to be deleted but inadvertently left out of draft.

17943 (w)(2)

Added in missing phrase “that a” from current text intended to be deleted but inadvertently left out of draft.

17943 (ab)(1)

Added in inadvertently dropped underline for the proposed new subsection number “(1)”.

17943 (ab)(2)

Added in inadvertently dropped underline for the proposed new subsection number “(2)”.

17943 (af)(1)(C)

- Added in inadvertently dropped underline for proposed new phrase “in similar rigid plastic packaging containers”.
- Need for change identified by OAL.

Added in missing phrase “of product” from current text intended to be deleted but inadvertently left out of draft.

17944 (b)

Added in missing phrase “for its containers” from current text intended to be deleted but inadvertently left out of third sentence of draft text.

Section title, for consistent formatting, added in period (“.”) at end of title of this proposed new section.

Added back in the “Authority” and “Reference” citations previously noted for deletion as these will remain in the Code of Regulations.

- Added in missing phrase “via certified mail” from current text to be deleted but inadvertently left out of second sentence in draft.

Section title, for consistent formatting, added in periods (“.”) after Section number and at end of title of this new section.

Changed the (c) to a (d) and removed parentheses from the number “1” at end of paragraph for correct cross-reference.

Added in inadvertently dropped underline for the proposed new subsection letter “(A)”.

17945.3 (d)(9)(A)3

Removed parentheses from the number “1” at end of paragraph for correct cross-reference.

17945.3 (e)(1)(F)

Changed term “Sections” to “Section” for consistent phrasing throughout the regulations.

17945.4:

Section title, for consistent formatting, added in period (“.”) at end of title of this proposed new section.

17945.4 (b)

Added in inadvertently dropped underline under segments of the proposed new phrase “I certify under penalty of perjury under the laws of the State of California that... complete.”

Added in missing subscripts for symbols “U_S” and “N_i” from current text to be deleted but inadvertently left out of draft.

17945.5 (e)(2)

For consistency with proposed revisions in the other subsections, added phrase “rigid plastic packaging” as intended but inadvertently left out of prior drafts.

- Added in missing number “6” from current text to be deleted but inadvertently left out of draft.
- Need for change identified by OAL.

Added in missing word “the” in second sentence, from current text to be deleted but inadvertently left out of draft.

- Section authority cited. Added in “Authority cited: Section 40502 and 42325, Public Resources Code” as this necessary citation was inadvertently left off of this proposed new section.
- Section reference. Added in “Reference: Section 42325, Public Resources Code” as this necessary citation was inadvertently left off of this proposed new section.

- Section authority cited. Added in missing authority from current text but inadvertently left out of draft.
- Section reference. Added in missing authority from current text but inadvertently left out of draft.

In row (3) of chart, added in underline under added word “Section” as this was inadvertently dropped in prior draft.
