Background

Senate Bill (SB) 876 (Escutia, Statutes of 2000, Chapter 838) was enacted to provide a comprehensive measure to extend and expand California's regulatory program related to the management of waste and used tires. One of the key provisions of this measure requires the CIWMB to adopt and submit to the legislature a Five-Year Plan that included proposed budget allocations. In addition, it requires that the Five-Year Plan be updated every two years. The current plan that was adopted in June 2007 covers Fiscal Years 2007/08 to 2011/2012. Staff will be revising the plan to cover Fiscal Years 2009/10 to 2013/14. We anticipate a draft revised Five-Year Plan will be presented to the Board in February 2009 and the final revised Five-Year Plan will be submitted to the Board for approval in April or May 2009.
